MINUTES OF THE ONE HUNDRED TWENTIETH ANNUAL CONVENTION OF THE MICHIGAN STATE COUNCIL KNIGHTS OF COLUMBUS

HELD VIRTUALLY
MARYSVILLE, MICHIGAN
MAY 23, 2020

William Chassé: Supreme Knight, Worthy State Chaplain Reverend Paul Erickson, Worthy State Officers, Worthy Past State Deputies, Worthy District Deputies, Worthy State Regional and Diocesan Directors, Worthy General Agents, and Convention Delegates, this is State Deputy Bill Chassé. Thank you for joining us today, and welcome to the annual meeting of the Michigan State Council. I now declare this meeting in order.

As we open this virtual meeting, I will ask our state chaplain, Rev. Paul Erickson, to open with prayer.

Rev. Paul Erickson: In the name of the Father, and of the Son, and of the Holy Spirit. Amen. O Mary, you always brighten our path as a sign of salvation and of hope. We entrust ourselves to you, Help of the Sick, who at the cross took part in Jesus' pain while remaining steadfast in faith. O Loving Mother, you know what we need, and we are confident you will provide for us [inaudible]. Intercede for us with your Son, Jesus, the Divine Physician, for those who have fallen ill, for those who are vulnerable, and for those who have died. Intercede also for those charged with protecting the health and safety of others and for those who are attending to the sick and seeking a cure. Help us, O Mother of Divine Love, to conform to the will of the Father and to do as we are told by Jesus, who took upon himself our sufferings and carried our sorrows so as to lead us through the cross to the glory of the Resurrection. Under thy protection we seek refuge, O Holy Mother of God. In our needs, despise not our petitions but deliver us always from all dangers, O Glorious and Blessed Virgin. Amen. In the name of the Father, and of the Son, and of the Holy Spirit. Amen.

William Chassé: Thank you, Fr. Paul. There are a few announcements I need to make as we proceed with this virtual meeting. We know that this will be a unique experience for all, including state officers, directors, and delegates, so I am grateful for your patience. Please do not mute your phones; the system automatically mutes participants. The minutes of the 2019 state convention and all reports of committees, reports of officers, and resolutions have been distributed prior to this meeting and posted on the state council website for your review. The deadline for objections and questions has passed. Our goal is to complete this business in 90 minutes, so many items will be abbreviated or eliminated. I ask that everyone, especially delegates, stay connected until we have concluded the meeting. If you are dropped from the call, please rejoin the call in progress by dialing 1-877-228-2184. The event ID: 119382.

Today, this virtual convention will be conducted under the amended rules and procedures earlier recommended and approved by the state officers. These will have been previously provided for the delegates, and no objection has been received, so they are adopted for use without objection. Due to the circumstances of the virtual state meeting, I have asked our state secretary and state treasurer, along with the executive secretary, Larry Grabowski, to serve as our credentials committee. I have also appointed brother Fred Boncher to serve as our parliamentarian for this virtual meeting. If there are any nominations today for state office, now would be the time to push *3 to be placed in the queue. When asked to speak, please be ready.

We are pleased to have our Supreme Knight, Carl Anderson, participating in our meeting today, and at this time I call on him for his message. Worthy Supreme Knight.

Carl Anderson: Thank you very much, and may it please our worthy state chaplain, Fr. Erickson; our worthy state deputy, William Chassé; and all my brother Knights; I hoped to be with you in person this year on Mackinac Island, but unfortunately the pandemic has made that impossible. Nevertheless, I applaud you for holding this virtual convention and I appreciate the extra effort you've made to make this teleconference meeting a reality. I especially want to express my gratitude to the archbishop of Detroit, His Excellency Allen Vigneron. It has been a privilege for me to work with him on the board of trustees of the Catholic University of America and in the transformation of the John Paul II Cultural Center into the St. John Paul II National Shrine. I also want to take this opportunity to thank my friends and former Supreme Directors Bob Stebler and Tom Wegener.

Well, this coronavirus pandemic has changed our daily lives, but it will not change our commitment to fraternity. This is not the first pandemic the Knights of Columbus has faced. In the 19th century and again in 1918, we remained strong and active as sickness spread. And what was true then is true now. Why? Because we have remained true to our principles. I have said before that where there is a need, there is a Knight. And this is a time of great need. And so once again we must stand together as brother Knights to meet it. We have the financial strength to address much of the suffering we see around us, but more importantly we have the fraternal strength to do the great works of charity that the times demand. As our leaders in Michigan, you have the responsibility to mobilize our efforts. Thank you for what you've already done; it is impressive. Your brother Knights will continue to look to you for leadership. Continue to show them the Knights of Columbus way to put their faith into action.

In response to this pandemic, in March we launched our new initiative, Leave No Neighbor Behind. It calls on all Knights to support our brothers, to support our parishes, and to support our communities; to feed the hungry; and to participate in blood drives. Our councils are the starting point in these efforts to leave no neighbor behind. And I would ask you to begin with the brothers in your council. Please contact every one of them, especially those you may not have seen or heard from in a while. Do they need our helping hand? During this time, no brother Knight should feel forgotten or left behind by his council. And then we should work with our local pastors to reach out to those in our parishes who may have a special need during this time.

At the start of Holy Week, we announced a multimillion dollar campaign to support food banks in the United States and Canada. We are providing urgent support to the hardest-hit communities and the neediest among us. Our initial commitment of \$1,250,000 was only the first phase of this campaign, and \$50,000 came here to Michigan to support the work of Catholic charities' food pantries. Many councils and individual Knights have contributed to our efforts.

Our work continues, and it must continue in the days ahead. In addition to our charity, we are also standing strong for unity with our Church experiencing serious financial strain. The Order established a \$100 million church loan fund for dioceses in the United States and Canada, and this will offer dioceses a \$1 million line of credit. And this will help them address the serious economic impact of the crisis.

We are also proud to sponsor the pope's Holy Week broadcast, including his historic *Urbi et Orbi* blessing of the city of Rome and of the world in response to the pandemic. Pope Francis has called on all Christians to unite their voices to heaven, and I urge every Knight and his family to continue to pray our prayer for the protection in time of pandemic.

As the pandemic continues, so will the need for charity and unity, and the same is true of fraternity. With all in-person Knights of Columbus meetings still canceled and reopening still uncertain in many places, we are finding new ways to bring brother Knights together, and this convention is a sign of what's possible. Our insurance agents and our customer service team at the home office also remain available to help members with any insurance or related financial needs. The challenges are great, but our determination to overcome them is greater still.

Here is a quick summary of what we have accomplished since early March. Given the Supreme Council's proximity to the epicenter of the US outbreak in New York City, we took early action, before most other companies, to ensure the health and safety of our employees and the continuity of our business operations by adopting a remote work plan with employees working from home. That transition went forward in an exemplary manner, as did the work of our insurance agents as they, too, transitioned to a new operating model to virtual online meetings of brother Knights demanded by social distancing. We also developed IT and procedural solutions to holding virtual state conventions and online exemplifications of our new ceremonial, and as I just mentioned, we announced our emergency church loan program, implemented a multimillion dollar food assistance program, and launched our Leave No Neighbor Behind initiative. So, as you can see, during this pandemic we will forge ahead together as brother Knights, and we will leave no neighbor behind, and we will come through this crisis stronger than before. I believe our response to this crisis will be recorded among the Order's finest hours.

This fraternal year, the Knights of Columbus reached two million members. This is an historic milestone. Now keep that momentum going, as you are in Michigan. You belong in the Circle of Honor. The day I was elected your Supreme Knight, I said we have a moral obligation to offer the benefits of membership in the Knights of Columbus to every eligible Catholic man. Now, nearly 20 years later, I believe this more strongly than ever. Fr. McGivney's gift to us of this wonderful organization was never intended to be a gift for only a few. It was always meant to be shared. The more men who join, the more lives we will transform, and the more communities we will serve. The more men we have, the more we will do for our parishes and the more Catholic families we will strengthen.

Now, a key component of our efforts going forward will be our new exemplification ceremony. It has already received an overwhelmingly positive response, and well it should. It teaches our lessons of charity, unity, and fraternity in a way that is compelling and grounded in the rich history of the Order. It will make it easier to bring men into our ranks and for those men to serve as council officers. This new ceremony provides a gateway to inspire the next generation of Knights and to strengthen our councils. Now it is available each week online, making it possible each week to exemplify new members and advance existing members to the third degree. And later this month it will be available online in Spanish and French. If you haven't yet participated in the new ceremonial, I encourage you to view it this Thursday evening.

As you know, men join the Knights of Columbus for the benefits of belonging to our great Catholic brotherhood. Our principles of charity, unity, and fraternity change lives for the better every day. Each day, we fulfill Fr. McGivney's dream of offering Catholic families financial protection they can depend upon through our commitment to insurance by brother Knights for brother Knights. The secret of our impressive growth is simple: through the spiritual genius of Fr. McGivney we have found a way to transform friends into brothers, brothers who are committed to one another. The Knights of Columbus offers Catholic men a path of Christian discipleship, a path marked by the guideposts of charity, unity, and fraternity. It is a path we walk not just one day or one hour a week, but 24/7, and these principles guide all that we do. Our insurance program successfully competes in the marketplace not in spite of, but because of, our Catholic principles.

You can be proud that our insurance program has been rated Superior by AM Best and Standard and Poor's. And you can be very proud of this: on April 6, Standard and Poor's released its review of North American life insurance companies, ranking them from strongest to weakest based on their financial strength and the outlook as to how well they are positioned to handle the impact of the coronavirus pandemic. Out of hundreds of companies in North America, only six were placed in the top category, and the Knights of Columbus is one of those six. Now this financial strength does not magically appear overnight; it is the result of a consistent and a sustained determination over many years to do what is best for our brother Knights in a prudent and professional way. Much of the credit belongs to our dedicated general and field agents, and I mean this especially about your agents here in Michigan.

Our program of insurance by brother Knights for brother Knights is a great responsibility. It merits the support of all of us. We have more than \$113 billion of insurance in force, protecting the financial future of our Catholic families. As leaders of your jurisdiction, remember your general and field agents can be your best partners in working to grow the order. Now our agents have the added challenge of continuing to serve our brother Knights without being able to meet with them in person. But you can help by encouraging virtual meetings between our field agents and our brother Knights. We should all remember that our insurance program and our charitable works arise from the same source—our responsibility to our families and those in need. Last year alone, our brother Knights gave more than \$185 million to charity and volunteered more than 76 million hours. All these efforts keep pace with our long history of helping the suffering and the marginalized.

And when it comes to defending the right to life, we will continue to lead the way. Just over 10 years ago, we launched a new initiative to place 1,000 ultrasound machines in crisis pregnancy centers. We've not only met that goal, we've exceeded it. To date we've placed more than 1200 ultrasound machines, and 66 of them—valued at more than \$4.1 million—are here in Michigan. If each ultrasound reduces the number of abortions by just one each week, then we will save more than 60,000 children in the coming year. Think of that: 60,000 children saved, and 3,432 children will be saved in Michigan. Think of that. Every day, 9 children will be saved because of what you have done here in Michigan. As I said before, this is the greatest humanitarian achievement in the history of the Knights of Columbus. But there is still much

more for us to do. We must continue to rescue the unborn until that time when they are once again protected by law.

We must also do more to strengthen the pastoral approach of our priests in confronting these difficult moral issues. That's why, more than 30 years ago, the Knights of Columbus established the Pontifical John Paul II Institute for Studies on Marriage and Family, and it is why what you did more than a decade ago to establish the Fr. Michael J. McGivney Chair of Life Ethics at the Sacred Heart Major Seminary is so important. The Lord has called us to be His witnesses, and especially to be His witnesses in our homes and in our parishes. That is why 7 years ago we launched the Building the Domestic Church program. And that's why we started our Faith in Action initiative. These programs deserve the attention of every council, and so does our powerful new video series for men, *Into the Breach*. Today I ask that every council promote these programs.

During this pandemic, when Catholics are spending more time at home, our programs to build up the church of the home are needed more than ever. Our history is one of which we can all be proud. Today nearly every jurisdiction can boast a hundred years of charity, unity, and fraternity; in Michigan, since 1901.

This year marks another milestone in the history of the order—100 years of charitable service in Rome to the successors of Peter. Recently the Supreme Officers and Supreme Directors traveled to the Eternal City, where Pope Francis received us in a private audience. That pilgrimage commemorated the first Knights of Columbus audience with Pope Benedict XV in 1920. In his message to us, Pope Francis praised our faithful witness in defense of life by support for persecuted Christians and all our charitable efforts. He also thanked us, and now I quote him: "for our unswerving devotion for the successor of Peter." I would ask you to pay particular attention to these words of Pope Francis. He said this: "In our world, marked by division and inequality, the generous commitment of your Order to serve all in need offers especially to young people an important inspiration to overcome a globalization of indifference and build together a more just and inclusive society."

I also believe that every bishop in Michigan can say the same about your work. And as we confront the terrible devastation of the Midland flooding, the Supreme Council will be sending you soon a donation of \$25,000 to help our brother Knights there and their neighbors.

Brothers, the Knights of Columbus is needed today more than ever before, not only to confront and overcome the coronavirus pandemic. We are needed today to protect and to build up our Church and to ensure a future of faith for our children and our grandchildren. My sincere hope is that amidst all these challenges we will grow closer to one another and to the Lord and that each of us will live more profoundly our principles of charity, unity, and fraternity in the spirit of Fr. McGivney.

May the Venerable Fr. McGivney and Our Lady of Guadalupe pray for us all. Vivat Jesus.

William Chassé: We are honored for you to join us today and for your comments. Thank you for your leadership in our Order, especially as we try to navigate through this COVID-19

pandemic. None of us have experienced this type of crisis in our lifetime. Again, thanks for sharing your time with us. We know you have a busy schedule; thank you very much.

Carl Anderson: Thank you.

William Chassé: At this time I recognize our insurance general agent Dan Thelen for his remarks to the meeting.

Dan Thelen: Most Reverend Father, Worthy State Deputy, brothers all, thank you for giving me the time to address you briefly during this historic virtual convention. This is an unprecedented time for all of us. On behalf of all the general agents in the state of Michigan, please be assured, first and foremost, of our agency's thoughts and prayers for you and your family. An agent's primary role is to be there for the brothers, so please do not hesitate to reach out to us if there is any way we can help during this time.

I want to assure you that our agencies and all the Knights of Columbus business and charitable functions are operational. Agents have transitioned to meetings and conducting business with members via Skype. This transition has been a great convenience for our members, and we're finding that both members and agents are really enjoying this new experience. And we're excited to incorporate this into our standard of practice once we move past this pandemic. The Supreme Council has shifted its business operations, too, and have been working remotely since mid-March.

This is a time, I know, when many of you have more financial concerns than usual. Maybe you're concerned about volatility. Maybe you need to be able to access more of your cash that's tied up in other places. Maybe you're thinking about adding insurance. Maybe you're looking for a new career. As always, the Knights of Columbus stands ready, by design by Fr. Michael J. McGivney himself, to help protect your financial future. Just this past month, at the height of the economic uncertainty brought about by the coronavirus, S&P's global rating published their report showing the Knights of Columbus as being tied for the most financially strong insurer in all of North America. That's a reality made possible only by our strong Catholic guiding principles and by the tremendous support and trust that you show us each year and every year. If we didn't have those things, we'd never be able to weather the storms like these, where trusted partners are needed more than ever.

So as we turn the page, God willing, from this moment to the next, I want to personally invite you to have a conversation with us. And I want to personally thank you, especially our state officers, for their support and their collaboration this past year. You know, we are all fraternalists. Just as the successes of our insurance business ought to be a point of pride for all of us, we are so incredibly proud of the work that all of you do and help support our Church and our communities. You are a beacon of God's joy and God's charity to Michigan, and we are honored to work with you and for you, and we are excited to tackle the next fraternal year.

I'll close with a few personal observations. I started my career with the Knights of Columbus in 2001. And it's been one financial crisis after another. The terrorist attacks on September 11, 2001; the collapsing mortgage crisis in 2008-2009; today's financial challenges with the

COVID-19 pandemic. Every event, we, the owners and insured members of the Knights of Columbus, have never, ever lost any money. In fact, every policy holder made money in these trying times. Rest assured, the Knights of Columbus was there during the past crises and will be there for the future crises, protecting and growing your families' finances along with sustaining our charitable giving.

Today, as mentioned, during the pandemic we're meeting our members through the secure virtual world. This new way presents some changes; yet, we still realize how important it is to make ourselves available to protect our membership and their dreams along with carrying out the promise to protect and serve. To think back to my childhood—of building your finances on a financially strong structure—it's the story about the three little pigs. One little pig built their house out of straw. One built their house out of sticks. And the third one built their house out of bricks. The Knights of Columbus owners have protected their families with their brick house.

I want to thank you all for your time, and I hope to see you all soon. Vivat Jesus.

William Chassé: Thank you, brother Dan, for your message and being with us today. And I also want to thank all general agents and field agents here in the state of Michigan for the working relationship we have. You are very, very important to us. Thank you for everything that you do.

At this time it is my pleasure to invite our state chaplain, Reverend Paul Erickson, for his report to the meeting.

Rev. Paul Erickson: Thanks, Bill. As is probably not surprising to many of you, especially to those who know me, I actually have to stand up and pace around because I tend be kind of a freight train; I get louder and more passionate as I go. But because of our circumstances I'll try to keep it a little bit more contained and let my energy come out in other ways.

Before I get into the message that I want to deliver, I want to first offer my thanks to Bill Chassé and the state board and their wives. I accepted the position as diocesan chaplain for the Diocese of Lansing because it meant that I got to work with Bill and men like Bill. And it's been an honor and a privilege to work with you, to work alongside you, and to help advance the Knights of Columbus in the state of Michigan. It's truly been a privilege, and I'm very grateful to all of you for your constant love and support throughout the years. I want to offer a very special thanks to Marybeth Chassé and Karen Winkle, who always seemed to know that, even as diocesan chaplain, I never really quite knew what I was supposed to be doing or where I was supposed to be going. And they were always very quick to make sure that I was included and understood what was expected. So I want to thank them profusely, again, for their love, their support, and their encouragement.

I actually want to piggyback off of a line that I heard our Supreme Knight mention. He mentioned that this would be the finest hour our Order, the finest hour of the Knights of Columbus. And I've got to tell you that is right on. Brother Knights, now more than ever, the world needs the Knights. Because you think about what's been happening. It's not just been happening in the Diocese of Lansing or Detroit or Saginaw or whatever. It's not just been

happening in the state of Michigan. It's not just been happening in our country. What's happening right now is a worldwide crisis.

And what the world will be looking for and what the world is already searching for, longing for, hungering for, is leadership. And, my brothers, if it's not going to come from us, it's going to come from someplace. The world is looking for someone to lead. And, again, our worthy Supreme Knight likes to call us the Knights of charity. Brothers, this is the time for us to put up or shut up. Either we're going to become the Knights of charity that we always claimed we were and we're going to lead the world through this, out of this worldwide crisis, or we should fade away; we should not exist. And if we're not actually going to lead the world in charity, then what's the point?

And, my brothers, that can seem like a daunting task—and perhaps it is—but I think that's precisely the reason why it's so important. Leadership is not for the faint of heart. Charity is not for the faint of heart. Love is not for the faint of heart. You look at what the most perfect icon of love is in our world—it's a crucifix. It's the Lord Himself showing us what it means to lay down our lives, not just for ourselves, but for all that we know and love and all that we believe. Brothers, this is our call. This is who we are. This is fundamental to our identity. This is fundamental to our reality as Knights of Columbus. And so now, more than ever, this is our finest hour. Now is not the time to shy away but to rise up.

And it's very interesting to me—I think the Knights unknowingly have actually been preparing us for this global crisis for years. We've been talking about the domestic Church. What have we been doing for the last few months? Brothers, that is what the domestic Church should look like. That is what the domestic Church should be. We need men, now more than ever, stepping up to lead their families, to understand and to know who Jesus is and be able to present His gospel message to their families and to their friends.

And so if you don't know where to start, how about the Gospel of Matthew? If you've read the Gospel of Matthew, move on to Mark. Then move on to Luke. Then move on to John. If you've read through the gospels, read the Epistles of Paul. If you've read through Paul, read Hebrews. If you've read Hebrews, read John. If you've read John, read Peter. If you've read Peter, read Revelation. If you've read the entire New Testament, go back to the Old Testament.

If you've read the entirety of Scripture, you know what you should do? Read it again. And then read it again. And then read it again. Because that's what it means to be a living word, my brothers. It means that the ink doesn't change on the page, but what it speaks to your heart, what it speaks to your mind, that's what changes. Because it's the same Spirit of God alive and at work in you that was alive and at work in the evangelists who wrote it. And so, my brothers, if you're already familiar with the Scriptures, it's time to start reading them again.

And it's not enough now to just pray by yourself in your room, but to pray with your family in the family room. It's time to show your sons and your daughters how to lead the rosary, time to introduce them to the Divine Mercy chaplet. It's time to show them what it's like to lead the Litany of the Saints or what it's like to participate in the novenas of the Holy Spirit. It's time for you to teach to your families who Jesus is so that together as one family united in love you can

pursue the heart of Christ that leads us always to the love of the Father. That's the whole point. That's all that we're really trying to do. That's all that the Christian has ever been trying to do is seek the Word of God and to do it in faith and with courage.

My brothers, if we're not going to be men of faith, not going to be men of courage, we have no business calling ourselves Knights. This is who we are. And, my brothers, we need you. And I speak not just for myself as the state chaplain of the Knights of Columbus, and I speak not just for myself as a priest, but the entirety of the Church, the entirety of the world is looking to you, asking, "Will you step up?" Will you come, and will you serve with faith and conviction? Will you serve with love and devotion? Will you proclaim the truth that you know, and will you show us the Father who loves you, the Father who loves them, the Father who created everything and holds it all, sustains it in being, even now?

It can be tempting, I think, at times to think that the ruler of the world is some governor or some virus or some circumstance or whatever. That is completely false. The ruler of the world has made Himself known, and it is Jesus. It always has been. It always will be. There is no other king. There is no other lord. There is no other master worthy of our time, attention, and service.

And so, my brothers, once again, it has been such a privilege to serve you as state chaplain for the last two years. This is an odd way, perhaps, to be leaving, and I wish again that I could be with you in person. It's always so edifying to be with men of courage, to be with men of faith, to be with men of conviction. But now, now we get to understand what it actually means to be part of the Body of Christ, for though I am not with you in person, I know that by my baptism and strengthened through the confirmation that I received, we are united. We are united, perhaps, now more than we ever have been before, for there is nothing now but the love of God that connects our hearts.

And so, my brothers, know that my prayers, my thoughts, my love go out to you, to your families. I hope that you remain safe and well. And may Almighty God bless you always, the Father, the Son, and the Holy Spirit. Amen.

William Chassé: Thank you, Fr. Paul, for your comments. As usual, very convincing and from the heart. Having you serve as our state chaplain these past few years has been a great inspiration for me, and I know I speak for all my brother Knights in Michigan when I say thank you for your guidance, your spiritual leadership, and especially your friendship. Thank you, Fr. Paul.

At this time I call on our state secretary for the report of the credentials committee.

Walter Winkle: Your Excellency, Worthy State Chaplain, Worthy Supreme Knight, Worthy State Deputy, worthy general agents, worthy council delegates, and worthy brother Knights, welcome. Upon review of the list of delegates based on information provided by our councils and cross-checking the list of members that have joined us today for this virtual meeting, our state treasurer and myself have the following number of delegates: five state officers, [each] with one vote; immediate past state deputy, one vote; state chaplain, one vote; council delegates, 340; for a total of 347 votes. Half of those votes plus one will be the winning amount; that equals 175, rounding up to the highest number. That completes my report, Worthy State Deputy.

William Chassé: Thank you Worthy State Secretary. Without objection, the roll of delegates submitted by the credentials committee will be the official roll of voting members for the convention. Without objection, the rules will be suspended, and the following shortened order of business will be adopted: prayer, appointment of committee on credentials report, approval of the 2019 minutes, reports of committees, reports of state officers, nomination and election of state officers, nomination and election of representatives and alternates to the Supreme Convention, consideration of resolutions, new business, prayer, adjourn.

At this time we will proceed with the approval of the minutes of the 2019 state convention, which were distributed before the state meeting. We have received no comments or corrections. There being no corrections to the minutes, the minutes are approved without objection.

At this time we will proceed with the reports of committees. As the various reports of committees were distributed prior to the state convention, without objection, they will be accepted as written and included in the minutes.

Let us move on to the reports of officers. As the various reports of state officers were distributed prior to the state convention, without objection, they will be accepted as written and included in the minutes.

I will now ask our state secretary if there is an update on the report of the credentials committee.

Walter Winkle: Worthy State Deputy, currently it stands at 340 delegates with total votes of 347, needing 175 to win the election. That concludes my report.

William Chassé: Thank you, Worthy State Secretary. To clarify what it takes to win, it's 51% of cast votes, not the number of delegates. Without objection, the revised roll of delegates submitted by the credentials committee will be the official roll of voting members of the convention. There was no revision; we will stay where we were.

We will now proceed with the election of officers. Please note, the nominations submitted to the state secretary will be considered as second nominations made to the floor in consideration of that respective position. It is important that voting delegates follow the instructions on how to vote. The voting will be anonymous. The system we are using records the votes but does not show how any particular delegate voted. Remember that only credentialed delegates have the right to the floor, and you must be recognized to speak. If a delegate wishes to address the floor, please push *3 on your phone and you will be placed in the queue. You may be contacted so we know your intentions to alert myself when to recognize you; please do not mute your phone. I have appointed Dan Fuller, Paul Palka, and Gary Kolbicz as the judge and tellers.

Nominations presented from the floor today will be restricted to a straightforward format. First nomination speech will be given 3 minutes. For example, you will say, "Worthy State Deputy, my name is John Doe, first delegate from council 1234," then start your speech. For the second nomination, it will be, "Worthy State Deputy, my name is Jack Doe, and I second the nomination."

As noted in the guidelines distributed and posted on our state council website, the following nominations were submitted for the positions of: State Deputy, Walter Winkle; State Secretary, Christopher Kolomjec; State Treasurer, Barry Borsenik; State Advocate, Charles McCuen. There were no other nominations sent it for these positions. Nominations are now closed, and I call on brother Ken Morrison, delegate from council 788, for the purpose of making a nomination.

Ken Morrison: Worthy State Deputy, I nominate the following slate of officers: State Deputy, Walter Winkle; State Secretary, Christopher Kolomjec; State Treasurer, Barry Borsenik; State Advocate, Charles McCuen.

William Chassé: Nominations are closed. Since there were no other nominations, without objection, there will be cast one ballot for the slate of officers on behalf of the delegates: State Deputy, Walter Winkle; State Secretary, Christopher Kolomjec; State Treasurer, Barry Borsenik; State Advocate, Charles McCuen. These brothers will serve a one-year term commencing July 1, 2020. Congratulations, brothers. These results will be posted on our state website.

Now we will move into the election of state warden. At this time I recognize Past State Deputy Michael Malinowski for the purpose of making a nomination.

Michael Malinowski: Worthy State Deputy, my name is Michael Malinowski, Past State Deputy, and first delegate from Monsignor Hunt Council #3312, Dearborn Heights in the Archdiocese of Detroit. In a couple of minutes we will vote for the person who will be our next state warden. I would like to nominate District Deputy Joel Kendzorski from the Diocese of Gaylord for the office of state warden. I'm thinking that many of you have never met Joel Kendzorski, or maybe you have. Perhaps it was at a state or diocesan meeting.

In the few remaining minutes I have, let me tell you about my friend Joel. Joel was born in Warren, Michigan, and when he was young his family moved to Posen. After graduating high school there, Joel attended Lake Superior State University and received a bachelor's degree in engineering. He also has an MBA in business. Joel currently has his own international consulting company, serving 33 different countries. Joel and his wife, Jan Marie, have been married for 31 years. Jan Marie works as a nurse in the area. They have four children. Son Jeremy is a member, along with son-in-law Andrew, and their son James, who is the deputy grand knight and the grand knight-elect will be doing the seconding today. And, oh, by the way, Joel and Jan Marie have 13 grandchildren.

In 2014, when the Most Reverend Bishop Raica was ordained for the Diocese of Gaylord, he called upon the talents of Joel to be on the Gaylord diocesan financial committee. While attending church in Posen, Joel was asked to join the Knights of Columbus Posen council, and after holding many council offices, he was elected grand knight in 2015. And like in many small councils, he had to worry if enough members would show up for a meeting so they could have a quorum. Would they take a committee's chairmanship, or would they volunteer to be a council officer? With Joel's leadership and encouragement, the council thrives.

If you're lucky to get a ticket to the Posen council's Hunters' Wild Game Dinner—just to let you know, it sells out every year—Joel is the chairman. Have you ever been to the Posen Potato

Festival? Maybe you've heard of it. Well, Joel organizes all the food booths for it. In 2016, then-State Deputy Kenneth Unterbrink, realizing Joel's skills, asked him to be a district deputy. Joel served both as grand knight and district deputy. And in 2018 our current state deputy William Chassé asked Joel if he would serve as Gaylord diocesan program director, so Joel is both district deputy and diocesan program director. I wish there was more time to speak about Joel, but keeping my words brief, as they say in Posen, "Dziękuję." Thank you, Worthy State Deputy, for this time to nominate.

William Chassé: Thank you, Worthy Past State Deputy Michael Malinowski. At this time, I recognize brother James Kendzorski for a second nomination.

James Kendzorski: Worthy State Deputy, my name is James Kendzorski, the second delegate from council #6657, and I second the nomination.

William Chassé: Thank you, brother James. If there are any other nominations, please push *3 on your phone, and you will be placed in the queue. Once you are recognized as having the floor, please be ready to speak. Are there any other nominations for the office of state warden? At this time, I recognize Past State Deputy Thomas Marcetti, Sr., for the purpose of making a nomination.

Thomas Marcetti, Sr.: Worthy State Deputy, thank you. I am Thomas Marcetti, Sr., Past State Deputy and first delegate of Fr. Patrick Cullinane Council #8710 of the Archdiocese of Detroit. It is my privilege to nominate Jim Kraus as warden for the Michigan jurisdiction of the Knights of Columbus.

Since I know what it takes to serve as a state officer, I believe that Jim has the ability and the commitment to serve on the state board. Jim is currently serving as the state membership director. In these trying times, he is committed to work to grow the order while maintaining safe and socially responsible methods to invite new members into our ranks, ultimately helping Michigan to achieve the Supreme Council Circle of Honor award for the first time in 10 years. Jim has served his council in various offices, including leading the council for two years with distinction as grand knight. Jim continued his service to the order as a district deputy and a diocesan program director. As a fourth degree Knight, Jim has served as faithful navigator, district marshal, and executive assistant to the Master of District #2, Michigan.

Jim has earned an associate's degree in criminal justice, a bachelor's degree in management and organizational development, and a master's degree in public administration. Jim also attended Michigan State University School of Staff Command and Executive Police Leadership to continually improve his professional skills throughout his career. Jim's more than 30 years of service to community as an officer of the Lansing Police Department is proof of Jim's willingness to take on the often-difficult task to protect and help people in need. Jim rose to the rank of captain before his retirement.

Jim and his wife, Amy, are active supporters of the Catholic faith community of St. Jude Parish in De Witt. He is a Eucharistic minister and has served as the chair of the building committee. Jim and Amy are always ready to volunteer to work on projects benefiting the parish.

For the good of the Order, I support and nominate Jim Kraus for state warden. I recommend that you add your support by voting for Jim Kraus. When balloting is open, please press '2' for Jim Kraus.

William Chassé: Thank you, Past State Deputy Thomas Marcetti, Sr. At this time I recognize brother Patrick Schneider for the purpose of making a second nomination.

Patrick Schneider: Good afternoon, Worthy State Deputy. My name is Pat Schneider, delegate and grand knight of council #7237 in De Witt. I am honored to second the nomination of Jim Kraus as our next state warden. Thank you, Worthy State Deputy.

William Chassé: Are there any nominations? Are there any other nominations? Are there any other nominations? At this time, we will proceed to the balloting for the position of state warden. Balloting will be open for two minutes. Press '1' for Joel Kendzorski. Press '2' for Jim Kraus. Press '1' for Joel Kendzorski. Press '2' for Jim Kraus. (*repeated several times during the balloting time*)

Please note, if you feel you selected the wrong number on your phone, re-vote and it will be recorded accurately. (*repeated several times during the balloting time*)

The ballot has been completed and the tallies confirmed. I now call upon our state secretary for the results.

Walter Winkle: Worthy State Deputy.

William Chassé: Worthy State Secretary.

Walter Winkle: With a total of 320 votes, the candidate with the majority of votes goes to Jim Kraus. He is serving as the state warden beginning July 1, 2020.

William Chassé: Thank you, Worthy State Secretary. Thank you, brother Knights, for your votes. Congratulations, brother Jim Kraus.

Now let us move into the election of delegates and alternates to the annual meeting of the Supreme Council. Your state deputy and immediate past state deputy are automatic delegates. In addition to these, Michigan can elect eight more third-degree members to represent us at the meeting. For the purpose of making a nomination, I call on Barry Borsenik, our current state advocate.

Barry Borsenik: Worthy State Deputy, I nominate the following members as delegates and alternatives to the Supreme Council meeting in Washington DC for the year 2020. Delegate 1: Thomas D. Meehan from council #10777, alternate Arthur R. Mucciante, council #529. Delegate 2: William R. Monahan, council 6548; alternate Thomas J. O'Brien, council #1300. Delegate 3: Richard T. Carl, council 9526; alternate Jerome J. Messing, council #3823. Delegate 4; Martin R. Brown, council #4404; alternate, Dennis L. Kaminski, council #10992. Delegate 5: Jeffrey J. Cypher, council #9962; alternate, John Armock, council #4036. Delegate 6: William F. Gorny, council #3312; alternate, Matthew J. Wierzgac, council #10963. Delegate 7: James J. Mattina,

council #10724; alternate, Robert A. Skwara, council #3129. Delegate 8: Michael L. Horvath, council #10006; alternate Philip M. Balmforth, council #7304.

William Chassé: Thank you, Worthy State Advocate. Nominations are closed without objection. They will be accepted as given and included in the minutes. At this time I call on our state advocate, Barry Borsenik, to present to us the report of the resolutions committee. Before he starts, let me state that the recommendation of the resolutions committee will act as an active motion. To acknowledge that, the approval of the committee's recommendation will be accepted. Worthy State Advocate, please proceed.

Barry Borsenik: Worthy State Deputy, let me first report that there were no proposed changes to the state council by-laws. As for resolutions, the delegates have received in advance a copy of the proposed resolutions. The resolutions committee met via an online meeting, Thursday, May 14, to review the resolutions, discuss, and make the following recommendations.

Resolutions 1 through 41 are for thanks and appreciation to individuals and organizations who cooperate with and support the efforts of the Michigan Knights of Columbus. The committee recommends adoption.

Resolutions 41 through 68 are to express sympathy and support of programs, causes, and positions of various efforts promoted by the Michigan Knights of Columbus. The committee recommends adoption.

Resolution 1-70, submitted by council #3092, has been ruled out of order as it attempts to add restrictions to what is already a voluntary charitable effort. It is otherwise redundant to the existing state council by-laws, and it would undermine authority granted to the state secretary and state treasurer in Article VIII, Sections 2 and 3.

Resolution 1-71, submitted by council #788, was recommended for approval subject to an amendment that the final paragraph be stated as follows: "That the Michigan State Jurisdiction proudly supports the nomination and election of William H. Chassé as a director of the Supreme Council Board of Directors of the Knights of Columbus." Council #788 has approved the amendment, and the committee recommends adoption.

Worthy State Deputy, I move that the recommendations of the committee by adopted.

William Chassé: Without objection, the recommendation of the resolutions committee is adopted. Thank you, Worthy State Advocate, for your work—and your team's—with the resolutions and by-laws.

Let us proceed to new business. The first item of new business is the adoption of a 2020-2021 fraternal year state convention. At this time, I call on our state secretary for the purpose of a motion. Worthy State Secretary?

It'll just be a minute, gentlemen.

At this time I call on our state treasurer for the purpose of a motion.

Christopher Kolomjec: Worthy State Deputy, I make a motion for the fraternal year 2020-2021 state convention to be held on May 20, 21, 22 of 2021 on Mackinac Island at the Grand Hotel.

William Chassé: If there are no objections, we will adopt the motion. Having no other new business, I call on our state chaplain to lead us in prayer for the canonization of Fr. Michael J. McGivney.

Rev. Paul Erickson: In the name of the Father, and of the Son, and of the Holy Spirit. Amen. God, our Father, protector of the poor and defender of the widow and orphan, you called your priest, Father Michael J. McGivney, to be an apostle of Christian family life and to lead the young to the generous service of their neighbor. Through the example of his life and virtue may we follow your Son, Jesus Christ, more closely, fulfilling his commandment of charity and building up his Body which is the Church. Let the inspiration of your servant prompt us to greater confidence in your love so that we may continue his work of caring for the needy and the outcast. We humbly ask that you glorify your venerable servant Father Michael J. McGivney on earth according to the design of your holy will. Through his intercession, grant the favors we now present. Through Christ our Lord. Amen. In the name of the Father, and of the Son, and of the Holy Spirit. Amen.

William Chassé: Thank you, Worthy State Chaplain Fr. Paul. Brothers, I want to thank everyone for their patience and time today. I wish this was taking place at the Grand Hotel this weekend, but life doesn't always work out the way we planned. These are unique times. Please pray for an end to the pandemic. Stay safe. The meeting is adjourned. God bless you. God bless the Knights of Columbus.
