State Protocol

The State Warden is the definitive source for protocol in the Michigan Jurisdiction. Feel free to contact him with any questions concerning protocol and seating for council meetings and events. For council events where a State Officer will be present, the State Warden will contact the Grand Knight several weeks before an event to review preparations and make recommendations.

Invitations

Invitations for State Officers, dignitaries and special guests should be sent out at least six weeks before the event. The longer the time before the event, the better the chances are that the State Deputy or another State officer will be able to attend your function.

All requests for a State Officer to attend a council function are to be sent to the State Deputy. In addition to the State Deputy, it is proper to request a specific State officer(s) or State Director attend as well. It is not necessary to invite the entire board to an event. In some cases, scheduling conflicts may necessitate that the State Deputy assign another representative of the State Council, or send his regrets.

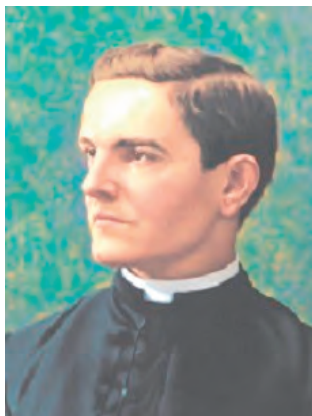
