The Knights of Columbus Board of Directors elected Patrick E. Kelly as the next Supreme Knight



Patrick E. Kelly has been elected the 14th Supreme Knight of the Knights of Columbus. Starting March 1, 2021, he will serve as chief executive officer and chairman of the board of the world's largest Catholic fraternal service organization, with more than 2 million members.

Mr. Kelly's election as Supreme Knight follows a distinguished career in the Knights of Columbus, the military and public service. For more than 25 years, he has a demonstrated track record of service to Church and country, which will serve him well in advancing the Knights' mission of Charity, Unity, Fraternity, and Patriotism.

Mr. Kelly has served as Deputy Supreme Knight since 2017. Prior to that, he served as Vice President for Public Policy for 11 years, spearheading the Knights' interaction with the White House, Congress and federal agencies. He has also served as State Deputy in the District of Columbia. As a longtime executive and fraternal leader of the Knights of Columbus, he has consistently strengthened its record of charity, advocacy, insurance, investment and membership growth.

Mr. Kelly served as the first executive director of the Saint John Paul II National Shrine in Washington, D.C., and oversaw the renewal of the facility after its purchase by the Knights in 2011. During his tenure, the shrine became a leading pilgrimage site and a source of education and inspiration for Catholics throughout the United States and the world.

Prior to his leadership roles in the Knights, Mr. Kelly pursued a lengthy career of public service. Most notably, he was Senior Advisor to the Ambassador-at-Large for International Religious Freedom at the State Department from 2005 to 2006. His responsibilities included serving as the Department's principal liaison with the Holy See and assisting with the formulation of U.S. foreign policy on religious freedom worldwide. He led U.S. delegations to the World Summit on Islamic-Christian dialogue (2005), the UN conference on interfaith cooperation (2005), and annual Sant'Egidio conferences. He has also held advisory roles on the House Intelligence Committee and the Department of Justice, where he specialized in counterterrorism and national security.

**From The State Chaplain

Before the 14th century, there was nothing much in the town of Avignon, in southern France. But from 1309 to 1376, however, this city of southern France became the home of seven popes, who were forced to flee Rome because of war. Avignon, as a result, began to prosper the moment the first pope arrived. For example, the most prominent architects of Europe were called in to design the gothic papal palace, complete with 39 towers. Many very well educated people followed the papal court, establishing Avignon as an intellectual capital attracting fine chefs, important poets, architects, sculptors and artists. Within a very short time, the papal court had transformed a one stop-sign town into a cultural metropolis.

The only problem with Avignon was, it was too nice. What was first intended as a temporary exile from Rome, turned into a most pleasant extended vacation. Once Frenchmen began to be elected as popes, there was no question of going back. The French Pope Gregory XI, was expected to continue the tradition of having the Holy See remain in Avignon. As Florence was waging war against Siena and Rome, it made great practical sense to stay in beautiful, peaceful France.

However, Gregory XI, shortly after accepting the office of the papacy, heard the voice of Jesus asking him to “feed my sheep” by returning the Holy See to Rome. So moved by this impulse of grace, Gregory made a private vow to Christ that he would move the Holy See back to its rightful historic city. He told no one of the vow he had made, but began to float the idea to the Cardinals and to the French King. As you can imagine, everyone laughed at such a proposition. They all said, “It is not safe in Rome, and Avignon offers all the comforts of life and more.” Therefore, perhaps thinking that his vow to return to Rome was a bit of misdirected zeal, Gregory listened to his advisors and shelved the idea for awhile.

But one day, in 1376, Gregory XI received a very well known visitor: the Siense virgin named Catherine of the Order of Preachers. You probably know her as St. Catherine of Siena, her feast day is celebrated every year on April 29th. But anyways, she came to the Pope, not about this issue, but instead she came at the request of the people of Florence to have the Pope lift the interdict under which they had been placed. Gregory XI knew of Catherine’s reputation for holiness, so he asked her privately whether or not he should return the Holy See to Rome. Catherine responded that she had no authority even to offer an opinion on the matter. But the Holy Father continued to press her, saying: “Do you think that I should return to Rome?” Catherine looked him in the eye and responded: “I think that you need to do what you promised Jesus you would do.”

Pope Gregory was speechless. He had told no one of this private vow, yet St. Catherine could see into his troubled heart. Strengthened by her directive, Gregory XI, against every other bit of advice he had received, ended the papal exile in Avignon. He returned the papacy to Rome amidst the consternation of the French Cardinals.

St. Catherine of Siena’s visit to Avignon teaches us a very important truth of the spiritual life: once we have promised Jesus that we will do something, we need to stand firm in our commitment, confident that his grace will not fail us. Even though we may face great difficulties and the voices around us are telling us otherwise, we need to be faithful to what we have promised Jesus we would do.

This applies to us because through the sacraments we have received, we have all made promises to Jesus Christ. Through our reception of Baptism, Confirmation and the Eucharist, we have made promises that we will turn away from evil, accept the Church’s teachings on the faith, and live a life that is consistent with those teachings which proudly proclaims through word and deed that Jesus is our Lord and Savior. Through reception of Marriage, we also promise fidelity and love to our partner in marriage. As Knights of Columbus, we promise we will serve and defend the Church. We promise in the first three degrees that we receive, that we will strive for the noble virtues of charity, unity and fraternity.

Today, we have a crisis of being faithful to commitments. Popular culture encourages us to do only what brings us the pleasure of the moment, rather than remaining faithful to our responsibilities. It is not always easy to stay true to your word. It is a challenge; that is one reason why we need God. It is God who gives us the graces necessary to meet the challenges we face. It is God who gives us His Spirit to help us love beyond the measure we think we are capable of and to serve those who are in most need of our help. Therefore, let’s make a conscious decision to invite the risen Lord and the Holy Spirit into our lives every day, so that we may grow in faithfulness and fidelity, and so that we may also follow St. Catherine’s words and do what we promised Jesus we would do.

As State Secretary, I would like to thank you for your prompt return of your per capita checks and Boysville Quota, If you have not received one, Please email our Executive Secretary, Larry Grabowski at L.Grabowski@mikofc.org and he can send you the amount. Remember that there are two invoices sent out each fraternal year. The first is sent around the end of July and to other is sent in January. They must be paid to be able to seat a delegate from your council to our State Convention. I would also ask that you please send any monies collected in behalf of the 10 For Charity and Sacred Heart Major Seminary Endowment Fund by the end of April. You will not receive an invoice for these because they are separate accounts that have full council discretion. I do ask of two things; I ask you to write a separate check for each account. The SHMSEF goes into our 501 c 3 Account and the 10 for Charity does not. The other is to place on the memo line what the check is for. If you do not have your council number on your checks, please include that on the memo line also! If you have more than one check, you can include in one envelope!

The Board and Several State Directors have been planning the State Convention since early January and continue to do so about 2 meetings a month so that your council delegates will have an enjoyable, fulfilling and spiritual experience. As of the date this letter is written, we are planning on continuing to plan for the State Convention and not postpone or cancel due to the Coronavirus. Hopefully by the time of the State Convention, there will be no need of this even being a consideration and all will be ready for our arrival. I would also encourage all of you to send delegates from each of your councils. This is an important tradition in Michigan to have such active participation. Do not let council limitations in funding stop you from encouraging your membership to volunteer as delegates even if the council can only partially reimburse or even if the member is willing to cover the costs. Many would love the opportunity and you might be surprised at the willingness of volunteers to go without council financial support. This is especially true during COVID when fundraising for councils has been limited.

As the Convention Chairman, if you have any constructive ideas as to making it even better, please email me to share them. It takes many people to make this as successful as it has been in the past. I would like to thank these individuals for taking the time to make this so. There have been some minor changes with COVID and the new management of the Grand with regards to hospitality. Although the hotel will permit the bringing of food and alcohol for your private use, any large or open hospitality the hotel requests that you purchase food and alcohol from the hotel directly. The cost is significantly higher but the Hotel will now waive the \$200 daily set up fee. For the average hospitality room, the higher costs will be offset by the waived fees and the headaches that come with transporting and maintaining all the food and drink.

I would also encourage you now to start putting your best programs that have been done this last fraternal year and present it for a service award during our convention. Your Diocesan Program directors can help you if you need some guidance on the best presentation. All the state winners in each category will be sent to Supreme to be judged. If you are awarded first place, you will receive an invitation to attend the Supreme Convention in Denver this year to receive your award. As a side note, any member and his family can attend the Supreme Convention. During the Month of May, the Supreme website will have the information available so that you can attend as a guest. I have done this for many years and have made several new friends while enjoying different cities each year. It appears that the next years Supreme Convention will be in Nashville and although these are what I have heard, they may change. If you do want to attend any of these in the future, I ask that you contact the State Advocate so that we can include you in some of the events that we attend.

Our Catholic Citizenship Essay Contest that was recently conducted saw more participation than in previous years. While it historically hasn't enjoyed enormous implementation by councils, there was a welcome increase this year in the number of councils that submitted essays to the state council. It's very rewarding for the council and the young participants, as well as quite easy to conduct. I'd urge any council to plan on running a contest next year; the resources available make running one simple and it doesn't have to have a huge number of participants.

The Knights of Columbus Board of Directors Elected Patrick E. Kelly as the Next Supreme Knight

Mr. Kelly served in the United States Navy for 24 years, on land and sea and on active duty and reserve status. As a Judge Advocate General, he specialized in international and operational law and served as the Commanding Officer of the international law unit at the U.S. Naval War College. He served on the staff of the Deputy Chief of Naval Operations and aboard the USS *Guamas* the Staff Judge Advocate for Amphibious Squadron Two. His personal awards include three Navy Achievement Medals, five Navy Commendation Medals and the Meritorious Service Medal. He retired from the JAG Corps Reserve in 2016.

Mr. Kelly has served as consultant to three committees of the U.S. Conference of Catholic Bishops (USCCB) for more than a decade: The Committee on Pro-life Activities, the Committee on Religious Liberty, and the Subcommittee for the Promotion and Defense of Marriage.

Mr. Kelly has been the Chairman of the Board of Directors of the March for Life since 2012. Under his leadership, the March for Life has become one of the most effective pro-life organizations in the world. He has also been a member of the Board of Directors of the National Catholic Bioethics Center (NCBC) since 2013. He has helped guide the NCBC in its mission to promote respect for the dignity of each human being through an understanding of how the moral teachings of the Church apply in health care and the life sciences.

Mr. Kelly holds a master's degree in theology from the Pontifical John Paul II Institute for Studies on Marriage and Family at The Catholic University of America, a law degree from Marquette University Law School and a bachelor's degree in economics from Marquette University, where he joined the Knights of Columbus in 1983.

He and his wife, Vanessa, have three daughters. They live in Connecticut.

Patrick E. Kelly to Continue the Mission of Charity, Unity and Fraternity

The Knights of Columbus Board of Directors elected Patrick E. Kelly as the next Supreme Knight on Feb. 5 2021, to continue the mission of charity, unity and fraternity established by the Order's Founder, Blessed Michael McGivney, almost 140 years ago.

Carl A. Anderson retired February 28, 2021, after more than 20 years of service as Supreme Knight and upon reaching the mandatory retirement age of 70. He leaves a legacy of Christian witness and service to the Catholic Church, to the Knights of Columbus and to communities throughout the world.

Patrick Kelly's tenure as the Order's 14th Supreme Knight began on March 1, 2021.

Statement by Former Supreme Knight Carl Anderson:

"The Knights of Columbus board has elected an extraordinarily well-qualified new Supreme Knight in Patrick Kelly. Patrick has dedicated his life in service to the Church, his country, and the Knights of Columbus. He has served as Deputy Supreme Knight for four years and is a well-rounded public servant with diplomatic and military experience. He is ideally suited to carry on the work of the Knights of Columbus as we enter a new era, faithful to our principles of charity, unity and fraternity, and in close collaboration with the Holy See and the bishops throughout the world. As Deputy Supreme Knight, Patrick has played a leading role in several major initiatives, including our international religious freedom efforts, our pro-life Ultrasound Initiative, and our new public initiation ceremony. He also served as Executive Director of the Saint John Paul II National Shrine, leading its transformation through the creation of its worship spaces and world-class exhibit on the life of St. John Paul II. Most recently, Patrick led the Knights' grassroots response to the COVID-19 pandemic titled "Leave No Neighbor Behind." Through this initiative, brother Knights around the world are serving those isolated and alone in quarantine, supporting food banks and blood centers in need of vital supplies, and providing other essential services. Patrick has the experience and strong faith necessary to lead the Knights into the future."

For over a decade, Patrick Kelly has worked at a senior level on the frontlines of the Knights' work in charity, advocacy, and the management of the organization's multibillion-dollar insurance and investment operations. Mr. Kelly joined the Knights as a university student in Wisconsin in 1983 and later served as State Deputy in the District of Columbia from 2012-2013. He was named the Knights' Vice President for Public Policy in 2006 and was elected Deputy Supreme Knight in January 2017.

Statement by Archbishop William E. Lori, Supreme Chaplain of the Knights of Columbus:

"The Knights of Columbus board has elected a brilliant new Supreme Knight with whom I have had the pleasure of working with for more than a decade.

Patrick Kelly is a devoted husband, father of three young daughters, and a man of deep faith with many years of experience as a public servant. He possesses the knowledge, experience and commitment necessary to carry the Order forward in service to our brother Knights, their families, our parishes, and our communities."

The newly elected Supreme Knight is a retired Navy Captain with 20 years of military service. In 2016, he retired from the U.S. Navy Judge Advocate General's (JAG) Corps Reserve, where he specialized in international and operational law and served as the Commanding Officer of the international law unit at the United States Naval War College. Previously, Mr. Kelly had a long career of public service that included advisory roles to Congress and the Department of Justice. Mr. Kelly also served as Senior Advisor to the Ambassador-at-Large for International Religious Freedom at the State Department. His responsibilities included serving as the Department's principal interlocutor with the Holy See and other nations on religious freedom issues.

Acceptance Statement by Supreme Knight-elect Patrick Kelly:


