The New Year is upon us. The celebration of Christ birthday has again come and gone. A new beginning for our country is in the making. Now we must evaluate our past successes. Our successes in our Order, in our jurisdiction, our districts, and our councils will need to be evaluated for our future actions. We are a jurisdiction of over 66,000 members and once were a jurisdiction of over 73,000 members.

Our celebration of the Eucharist is being attended less frequent by our youth. Our children are leaving the Catholic Church in an alarming rate. It is said that 30% of our Catholic youth that leave our Catholic Christian Doctrine or now the Catholic Faith Formation classes in our parishes, believe that the Eucharist is a Symbol of the Body and Blood of Christ. Our Catholic parents accept that cohabitation is a normal in our society. Marriage is later in life and divorce is at 50%.

We, as Knights of Columbus have been asked by our bishops of promote the Supreme Knight's Carl Anderson initiative of “Building the Domestic Church, While Strengthening Our Parishes.” Through this initiative, the Order will promote various programs that support Christian family life and encourage councils and families to more fully integrate with the sacramental and social life of their parish. We thereby hope to not only help each family participate in the Church's mission of evangelization, but to also strengthen our members and revitalize our parishes.

Supreme Knight Carl Anderson states “The family as domestic church is central to the work of the new evangelization and to the future sustainability of our parishes. ... The Knights of Columbus is providentially positioned to play a key role in the new alliance between the Church and family.”

Councils are asked to promote some of the our current programs including: A Family Fully Alive, Consecration to the Holy Family, Father's Day Affirmation of Wedding Vows, Holy Family Prayer Program, 5<sup>th</sup> Sunday Rosary Program, Journey to the Inn, and Food for Families. These along with A Community of Prayer, A School of Faith and Charity, and A Mission of Evangelization are part of the strategy for the family.

We as Knights of Columbus, as fathers, as grandfathers are asked to involve ourselves more deeply in our families, with our children and our grandchildren. If we, the men of the family, are involved in the spiritual life of our families, then we will be successful in the mission of Building the Domestic Church, While Strengthening Our Parishes. We, as men are the key to success. I would invite all Knights of Columbus members to ask their council for a copy of the new 2015 version of ‘These Men Called Knights’ and read the pamphlet. Then ask your wife and children to read the pamphlet to know why you are a Knight of Columbus.”

Happy New Year to you all as we enter upon 2017!

With the end of the Holy Year of Mercy, we, as Knights have entered upon a new Initiative, directed by our Supreme Knight, to build up the Domestic Church (our families) in concrete and direct ways. Your State Council has been preparing such a program throughout this past fall, and it was announced and brought forward for action at the Winter Meeting in early December. It is the will of our Michigan bishops that we proceed enthusiastically with our plan and I have made known to all the District Deputies a methodology to be brought to each Council for implementation.

I would like to specifically note that this initiative was close to the heart of our former State Deputy, Robert Fox, who asked that I would make sure that it moved forward with the full support of our current State Deputy. Last summer we met with the bishops of Michigan who were very enthusiastic about Knights taking part in this program, and saw it as a great tool in the New Evangelization. Upon our return from the Supreme Convention in Toronto a committee was in place to provide all Councils with a clear plan for success and education on the initiative so that the direction of our Supreme Knight may be followed and that Grand Knights may be clear on how it can be easily enacted in each of their Councils. We met with the Bishops again on December 7 to inform them on our progress. I am pleased to tell you that this plan, will encourage not only our Knights, but all young men with families in the parish to form small support groups to proceed with an education on the basics of what every Catholic should know, and to be nourished and

At the beginning of this New Year, Joyce and I hope that your holidays were blessed with faith, family and friends. May Peace be your gift at Christmas and your blessing all year through!

It is January and the campaigns and election is over – Thank Goodness! The hype and promise now gives way to actual work by our elected officials. There are many issues that they will take up over the coming months, and we must pray that for the good of all the people, including the least among us, are all given the same considerations to protect and advance their futures.

As Knights and as Catholics we have our tasks at the start the new year. We continue to fight for Religious Freedom; the 44<sup>th</sup> Anniversary of Roe v Wade will be observed; and the assault of pornography and the decline of civility continues in our media and airwaves. Now, however, it seems we may have some greater influence in the political centers. With our continuing hard work and focus victories may be at hand.

As is our habit we take the beginning of the new year to take a hard look at our progress as Knights leaders, where we are in our membership and our programs. Throughout this issue of the Michigan Columbian there are articles and information for leaders and Knights to review. Please read them as they deserve our attention and our action.

I've often said that it is a great time to be a Knight. And that is true. The Order continues to increase its charitable giving in both dollars and hours. The Order continues to increase its protection of its members and their families. And it does so in a most ethical manner. The Order continues to be financial sound. And the Order continues to grow in members and in councils and in jurisdictions.

The Order also continues to bring its principles to our social fabric by supporting life, by supporting religious freedom, by supporting Christians in the Holy Land and by lobbying Congress on behalf of Christians in Iraq and Syria. The Order does this because they are the right things to do if you are a Catholic, Family, Fraternal Organization.

My Brother Knights and Ladies, the Order that we belong to is in need itself. It needs the help of Michigan Knights and its families. While Michigan is one of the largest contributors in Charitable dollars and hours, and our programs are annually recognized on an international level, over the last few years our membership has declined to a level not seen since June of 1980 at the end of PSD Bill Walsh's term.

The problem is twofold – 1. Michigan's gross intake each year has dropped by a third from just a few years ago. 2. Michigan's member's average age is now over 61 years old, and the we are getting older. Our dropping intake, compounded by not recruiting younger members, is causing our membership to shrink and to age.

Our Supreme Knight has reinforced that growth is our primary responsibility. A portion of the Supreme Knight's message is below:

“Our responsibility as the leaders of the Knights of Columbus is to assure the continued growth and sustainability of our Order. This is our first and primary responsibility.”

“While we have other goals and activities that are necessary, no other task is sufficient to advance the Good of the Order if we do not advance membership growth. Everything we do depends upon membership,” he added.

Today there is a challenge that has to be met, he continued. Supreme Knight Anderson pointed out that the Knights of Columbus must recruit younger men and fathers of young families. Our councils need to emphasize programs more relevant to families with young children and we need to use recruitment tools that rely upon enhanced Internet and web-based connectivity.

It is necessary, he said, to recruit younger members in ways that respect the more limited time they have to dedicate to volunteer activities and to schedule council activities in ways that respond to the more limited time young fathers have to participate in activities outside the home.

“Let's remember this: Father McGivney was not yet 30 when he founded the Knights of Columbus with what was described at the time as the 'young go-ahead men' of New Haven,” the supreme knight continued. “And I am totally confident that had there been a World Youth Day in 1882, Father McGivney would have been there with his brother Knights. Father McGivney founded the Knights of Columbus for the young working men of his day, to protect their families.”

Our charitable works, our programs, our stance as the right arm of the catholic church, in solidarity with our bishops and priests, these are baked into our very being. Now is the time to let others in on what we know – the Knights of Columbus is the place for every catholic man and his family.

As PSD Bob Fox promoted, we must encourage more faith formation in our council chambers, in our council programs and in our council members. This is what our younger men and family desire. As Michigan continues to implement the Building the Domestic Church Initiative, as we embrace the aspects that enhance the members' and councils' evangelistic

### FIJI PROJECT AS A RESULT OF THE WINSTON CYCLONE

On February 20, 2016, the Winston Cyclone hit the Country of Fiji as a category 5 Cyclone with winds of 145 mph and gusts of up to 190 mph. The Country of Fiji has a number of Islands. On the Island of Taveuni is a Village of Vuna. The village of Vuna is where the pastor, Fr. Kusitino Cobona was raised. Fr. attended Holy Cross Catholic Church in the village of Vuna. When the Cyclone hit the Island of Taveuni, it destroyed most of the homes and crops. Holy Cross Catholic Church was heavily damaged. Mason Council #9182, at St. James Catholic Cross, decided to help Holy Cross Catholic Church in Vuna. The Mason Council #9182 held a special Fish Fry after Lent for the project. With the funds raised from the Fish Fry, a Silent Auction, and donations from Council #9182 and other sources, we raised over \$18000.

The second part to the project was to collect clothing and supplies to be sent over to the Village of Vuna. St. James purchased a container measuring

Here we are 6 months into the 2016- 2017 fraternal year. All the councils should have their form 185 (Council Officers elected) submitted along with their form 365 (Directors assigned) and your first half audit report. The second quarter of the MI-1 (Michigan Achievement & SP7 tracker) is due now which will tell me how well you are doing with your programs. This in turn will tell me how you are doing with membership recruitment.

There has been a major change in the requirement for the Columbian Award. The new requirement is that **at least four (4) of those programs need to be designated as "Domestic Church" programs.** Please visit [www.kofc.org/domesticchurch](http://www.kofc.org/domesticchurch) to review the most up-to-date list of programs and activities. The following programs currently carry the Domestic Church designation:

Please visit the [www.mikofc.org](http://www.mikofc.org) website to see the new SP7 (Columbian Award) form. We are currently working on revising the MI-1 form to include these changes. We are targeting April 15<sup>th</sup> as the date the revisions will be complete. You will not lose anything you submit prior to that date so please continue to list your programs.

Remember to complete your 1728 Annual Survey of Fraternal Activities by January 31<sup>st</sup>. This is the form that is used to maintain our charitable status.

Remember also to submit your Partnership Profile Report with Special Olympics - #4584 - due January 31<sup>st</sup>.

This is the form that records the money and hours dedicated to the Special Olympics. The jurisdiction in Supreme that records the most hours and money for this will receive a check from Supreme for \$10,000.00 to be presented to Special Olympics. For the last 5 years Michigan has received this check so please get this submitted by January 31<sup>st</sup>. You can claim the hours and monies collected for the MI drive as the state uses their share to support Special Olympics.

In closing I would remind you to be visible when you are participating in K of C programs. This is one of the ways we can increase membership.

### INGREDIENTS FOR SUCCESSFUL COUNCILS

A successful Knights of Columbus Council qualifies for State and Supreme council awards because of the programs they offer, achieving membership and insurance requirements, being involved in parish and community activities, and having committed members who enjoy what they do in service to others. That's a tall order, but one that quality councils strive to achieve.

What's the magic formula that results in a quality council? The three main ingredients are programming, leadership development and communication. When councils focus on these, they draw new members, activate senior members, and develop leaders who will carry the council mission into the future.

At the start of the fraternal year in June or even at the beginning of the second half in January, council officers and directors need to project the programs they intend to do while evaluating the success of past programs. With the schedule planned, the chairmen, budgets and membership recruitment components can be put in place. This is essential for a sound organization to which men want to join.

If effective programs are to be held, they need leaders. This is where new and senior members need to learn what jobs entail and the responsibilities of chairmen and officers. The State and Supreme Council offers training on their websites. State training is provided in June, and is now being offered to districts throughout the fraternal year. Council leaders need to encourage their members to attend and put what they learn into practice.

The third major ingredient is communication. Council leaders must ensure they are in contact with their members through newsletters, websites, email contacts and invitations to participate in council sponsored and supported activities. It may be easier to ask the same men and families to work on projects, but it doesn't get new members and those who may not be active to feel a part of the council's work. When men aren't active and they don't feel a sense of belonging, it becomes easier to drift away and drop their membership. Financial secretaries need to make it a practice to periodically call senior members who don't attend council meetings and programs.

District Deputies receive training on developing successful councils. They bring ideas and a sense of direction that are guides for their councils. They want to be of help, but councils need to accept what is offered to them.

Thus far recruitment efforts in Michigan so essential to growing councils have been lacking. A gain of 675 new members is diminished by 367 who have left the K of C since July 1. The number who drop their membership can be reduced when men feel they are involved, useful and wanted. Encouragement and recognition cement members' commitment to the Order. Active councils with growing membership come through the ingredients of program, leadership development and communication. The other side comes through programs that men in the parish and communities want to be a part. Programs are the key to getting members while participation and communication give them a reason to stay.

These ingredients are the simple solution that take real commitment to make reality. Who can deny how important they are for success. Now the question is: Will councils do what's necessary? Do leaders believe that implementing these ingredients will result in their council's success? If the answers to these questions are "Yes," the Knights of Columbus in Michigan will grow and prosper.

The first question has been "Do Priests, Deacons or Seminarians take the Degree by observation or as a regular candidate?" The answer is that Priests always take the degree by observation whether he is wearing his collar or not. A Deacon or Seminarian takes the Degree by observation if he is wearing a collar. Some Dioceses allow Deacons and Seminarians to wear a collar, but some do not. If a Deacon or a Seminarian does not wear a collar, he goes through the Degrees as a regular candidate.

Another question that has been asked me is "Can a 17 1/2 year old Practical Catholic join the Knights of Columbus?" We all know that the Constitution says

you must be Male, 18 Years Old, and a Practical Catholic. Well, Supreme has said that you can initiate a 17 1/2 Year Old, Male, Practical Catholic if you get permission from your State Deputy, and he has gone through your Admission Committee and was approved.

I really hope you had a Very Merry and Holy Christmas. The birth of our Lord Jesus Christ is why we celebrate Christmas. We are now starting a New Year. Let's look at our council rosters, and see who has not yet gone through the Formation and Knighthood Degrees. The new ways are so religious now. Our Founder, St. Louis Guanella, spent his life caring for people with disabilities, and felt strongly that we all have a responsibility to care for those who cannot care for themselves. In his own words, he said “We walk together with the people entrusted to our care. Every step of the way, we bring to them the heart of a father or mother, of a brother or sister, traveling the same road towards their greater well-being. Therefore, we stand by their side as journey companions, not superseding, but respecting individual freedom and harmony.” As we enter the season of Advent, we thank the Michigan Knights of Columbus and their wonderful Ladies, who stand firmly at our side as our “journey companions,” helping us to realize our dream of creating a new St. Louis Guanella Village on the property we own here in Chelsea, Michigan.

The new St. Louis Guanella Village will be an effort where together, we will build an “intentional community” where all of the service elements we provide will be brought together for the people with intellectual and developmental disabilities who call SLC their home. This includes children’s services, direct care for adults, assisted living for people with I/DD, and family homes for parents raising a child with I/DD who would like to live independently within our Village.

Several milestones occurred this fall to set the wheels in motion. First, our Groundbreaking Ceremony took place on September 29, 2016 with 275 people and members of the State Council in attendance (see IPSD Bob Fox’s column). Then at the beginning of November, Stante Excavation arrived from Northville, MI to begin re-shaping the land and laying out the infrastructure for the new Village; including roads, water, and sewer. Our warm Michigan November actually helped us to move quickly on our project as these huge earthmoving machines carved out the engineering designs that have been years in the making.

Finally, the financial commitments that we have received from the Michigan Knights of Columbus have been critical to our future success, and we couldn’t be more grateful. Our State Council Officers have committed to support the St. Louis Guanella Village Project in the amount of \$250,000 over the next ten years, (\$25,000 per year), and the successful fundraising efforts that come from the annual MI Drives help to the pay for these pledges. The State Council was also recently present at our Annual Fall Dinner Auction at St. Joseph Mercy Hospital-Chelsea, and State Deputy Kenneth Unterbrink presented us with a \$25,000 check to help us purchase a new generator.

Our residents can see their dreams coming together as they look out their windows each day at the farm fields shaping their new homes, and they know that their prayers are being answered when they ask Our Lord to look over them. As Fr. Guanella said, “It is God who Works.” May our communion of Saints, led by St. Louis Guanella and Fr. Michael J. McGivney, continue to bless and watch over the Michigan Knights of Columbus and their families, and all of their good works, for the people in the world who are abandoned and have no one. Thank you all for sharing in our journey of faith, for being part of our family, and for caring so much for “God’s Special People.”

## Dearborn K of C donates bicycles to veterans through “Wheels for Warriors” program



They’ve helped protect the country’s freedom, and now are getting some freedom of their own.

Four local veterans’ daily lives will be a little easier, thanks to some new wheels from members of the Msgr. Schulte

Assembly Knights of Columbus.

The group marked Veterans Day by giving bicycles to the four men — who served in Vietnam, Kosovo, Operation Desert Storm and Operation Iraqi Freedom — through the “Wheels for Warriors” program.

The nonprofit organization enriches the lives of local veterans by providing a means of transportation, exercise and rehabilitation. More than 97 percent of donations are used to put bicycles in the hands of veterans for travel to work, grocery stores, doctor’s appointments and other daily activities.

Robert Mincel, navigator of Msgr. Schulte Assembly Knights of Columbus, and purser Don Brezovsky were instrumental in organizing the bicycle donation. About \$2,000 was raised by allocating portions of members’ annual dues.

“We’re the Knights of Columbus fourth degree, which is considered the patriotic degree, so we were trying to do something for our vets for a few years,” Mincel said. “In December, we put wreaths on the veterans’ graves at St. Hedwig Cemetery, and while we were talking about that, we decided to do something for the vets who are still living.”

They came across the Wheels for Warriors program, which has its local headquarters in Livonia, and invited a representative to explain the organization’s purpose at one of their meetings.

“With most of our vets, the main issue for them is transportation,” Mincel said. “They have no way of getting around. The bicycles enable them to get to work, school, doctor’s appointments and various things.”

The bikes came from D&D Bicycles in Westland, which agreed to service them for the next three years.

“Say if a veteran wants to bring their bicycle in and get it checked, they will fix flat tires and provide all those types of services,” Mincel said.

**Holy Redeemer Council 16092** in Vanderbilt, with the help of family members, performed the fall cleanup of the parish grounds in early November. Annually, the council also participates in their local “Adopt a Road” program and cleans over three miles of old US Highway 27.

**Monroe Council 1266** built and installed 150 white crosses for St. Michael the Archangel Parish. The 150 white crosses represent the total number of abortions taking place every hour of every day. Council 1266 also sponsored the informational sign accompanying the two-month display.

### St. Louis Center Liaison Robert W. Fox, IPSD



Christmas came early for the St. Louis Center this year. The goal and planning for the St. Louis Guanella Village was no longer a dream. On Thursday September 29, 2016 following a gracious reception the celebration began. In front of a packed house including Congressman Tim Walberg (R 7th Dist.), Legacy Campaign Chairman Norm Newman, Judy Rumelhart of the Towsley Foundation, John Thorhauer CEO of the Chelsea United Methodist Retirement Community, Knights of Columbus State Officers and many others, gathered in the gym for the official ground breaking ceremony.

What was to be an outdoors event did not go as planned. Mother Nature threw a curve ball, RAIN! Not to be deterred three kid's swimming pools substituted for the outside and the "ground breaking" proceeded.

Included in the evening's festivities was the presentation of a check in the amount of \$25,000.00 to the St. Louis Center, the initial check of the Michigan Knights of Columbus pledge on the building of a Children's Home by Immediate Past State deputy Robert Fox.

The project is now well underway. With the unseasonably weather crews have been hard at work installing underground utilities and cutting in the roadways. The St. Louis Village is becoming a reality.

I would like to share some information with the new brother Knights, and even those of long membership, who possibly might not know St. Louis Center.

St. Louis Center was founded in 1960 by the Servants of Charity Congregation of missionary priests and brothers working worldwide on behalf of the poor, the abandoned and individuals with intellectual and development disabilities (I/DD). The Center's mission is to be a caring, residential, family living and learning

environment providing for the physical, emotional and spiritual needs for children and adults with I/DD.

Historically adults with I/DD passed away well before their parents. As a Result, many parents thought they would out-live their child, but in fact, with much better care radially available and the children living more active lives they are now out living their parents. These adults with I/DD, now without parents to look after them, face a crisis of major proportions, most are unable to communicate their plight, and most end up being wards of the state.

The number of adults with I/DD age 60 years or older is projected to nearly double from 641,860 in 2000 to 1.2 million by 2030. Over 75% of people with I/DD live with their families. More than 25% of family caregivers are over the age of 60 years; 38% are between 41-59 years. An estimated 2,874,604 people age 55 and older were caring for a family member with I/DD or significant functional limitations in the U.S. in 2005 and the numbers have increased significantly. Individuals with I/DD for the most part do not have a voice. They cannot articulate their situation. They can only rely on someone advocating for them. This is particularly true as they age and suddenly require special care. This we need to recognize that if it wasn't for our goodwill and generosity these adults with I/DD would be left to fend for themselves which they cannot do.

I would like to share something I have witnessed at my home parish, Holy Redeemer in Jenson MI, for many years, on which exemplifies the Centers mission.

I have watched Joe, little Joe as we call him, for some time now. Joe lives in a group home but attends Sunday mass with his parents. This past Sunday we sat behind Joe and his parents. His attitude during mass is what all Catholics should have. He listened to the readings, not planning what they would do with their day. He was not on the cell phone. His hands held as in prayer, not stuffed in their pockets or folded across their chest, or playing with their hair. Joe was at MASS, something very important to Joe. Many Catholics could learn from him. Did Joe completely understand? I would believe in his world he did, certainly in the eyes of God he did. To me his attitude during mass and prayer in general is one which all Catholics should have. Joe is one of God's special children. We need to display our faith as Joe does.

the problem that Joe, now 46, and many others with I/DD face is the reason for St. Louis Guanella Village. Please take time to learn more about St. Louis Center and the St. Louis Gaunella Village.


