A couple of years ago, there was a report put out by CBS that said that Iceland has nearly eliminated Down syndrome from their country through prenatal testing and abortion. Apparently when the mother has prenatal testing done, and the test comes back positive for Down syndrome markers in the child, the mother is typically encouraged to choose abortion.

In response to that report, a woman by the name of Ellen Stumbo wrote an article of her own entitled: ‘What That CBS Report on Iceland’s Abortion Rate Failed to Say About Down Syndrome.’ And this is what she said:

“A recent CBS news report on Iceland’s abortion rates and almost extinct Down syndrome population has the Down syndrome community talking.

As the mother of a child with Down syndrome this makes me realize how little our world in general values people with disabilities. I should not have to reason with someone why my daughter deserves to be alive, but one of the most common questions I get asked is: ‘Did you know before she was born?’ To me, this question implies children with Down syndrome are not wanted. My daughter is wanted, and she was wanted when a level II ultrasound revealed several markers consistent with Down syndrome.

But let me be honest – at the time, her diagnosis felt devastating. It felt devastating because my disability attitudes were found in ignorance and pity. I only knew stereotypes about Down syndrome. I thought of disability as something tragic. I did not spend time around people with disabilities. I did not know, and media did not help as the portrayal of people with disabilities is lacking accurate representations.

When my daughter was born, she challenged what I viewed as perfect, worthy, important, and valuable in life. I had made wrongful assumptions about what her life would be like because of my negative disability attitudes, only to quickly recognize her life had the same value as someone without a disability, and her life was just as beautiful and full. The treasures I have discovered along the way because of my daughter’s diagnosis remind me our greatest contributions are not found in our strength, performance, eloquence or confidence.

I won't say Down syndrome is 'easy' because parenting a child with a disability does bring extra challenges. But challenges are not what define the value of life. Because what exactly determines the value of a life? The value of a child...any child?

Should the value of a child's life be reduced to their academic performance? Then why is the life of a child with Down syndrome held to this standard? Should the value of a child's life be reduced to their medical conditions? Then why is the life of a child with Down syndrome held to this standard? Should the value of a person's life be reduced to the job they will have? Then why is the value of a person with Down syndrome held to this standard?

Down syndrome is not just a condition or a statistic, Down syndrome is a person, it is people like my child.

Expectant parents do not really know what Down syndrome is and are left with only the medical opinion of the condition. When you are pregnant and your baby has a possibility of having Down syndrome, doctors' response sadly is often not a welcoming one.... Like our pediatrician whose disability attitude was 'pity' as he confirmed the diagnosis at birth. 'I am very sorry to tell you this, but your child does have Down syndrome.'

Maybe it's time we move from being 'sorry' to offering support... When I hear an expectant mom is going to have a child with Down syndrome I say, 'Congratulations. I know it might be hard to believe it now, but you might come to love Down syndrome as part of who your child is. You will experience shades of color you never knew were possible. Ask me questions, as many as you have. I am here for you. You are not alone.'"

As Knights of Columbus, we help people know the dignity of people born with disabilities. The MI drives that we do every year isn't simply a nice thing we do, it is a vitally important thing that we do. It is vitally important because the world needs our witness as to the infinite value, worth and dignity of every human life. It is vitally important because there is a community of people who needs our help. It is vitally important because serving these very special people helps us to become more human and more humane. This is why we need to continue and grow in our efforts to support this community so that our generation and future generations may know of the blessings that God's special people are to us and our society.

My Brother Knights and families, thank you very much for the amazing growth that Michigan has seen during this first quarter of the fraternal year. As I write this, we have added 348 new members. By October 1<sup>st</sup> this number should be well over 475 new members. This growth has been achieved during an unprecedented time in history, with limited mass attendance and a lack of hands on parish and community projects. Let's continue to invite new members to join and not let COVID-19 limit us in 2020. The Knights must be leaders and an avenue of outreach to our Catholic communities, therefore we need membership growth.

“Leave No Neighbor Behind” is a timely and unique program well suited to a pandemic. Has your council taken advantage of this program? We all need to call our Brother Knights and help them through being isolated and away from receiving communion. When the time is right, we need to invite everyone back to mass, and personal phone calls will be key to this evangelization effort. Please use the format of “Leave No Neighbor Behind” to communicate with your Brothers and Parishioners and remind them of the coming Beatification of Fr. McGivney. While you are making these phone calls, remind them of how to use online membership programs such as e-membership [kofc.org/joinus](http://kofc.org/joinus) and our virtual Exemplification. I thank you all for being caring and faithful leaders.

I pray that we all can soon return to a sense of normalcy in our meetings and programs. With that return to normalcy, we need to plan in-person events including DELTA Church drives. Regardless of whether our parishes are fully open, each council's leadership team needs to be prepared. I hope you are all holding monthly meetings and planning events that are COVID-19 safe and respectful for our catholic communities. If you need help in planning in-person recruiting events please reach out to your District Deputy, Diocesan Membership Director, your Regional State Deputy Representative, or me, your State Membership Director.

Through July and August, our Supreme Council helped us by providing virtual Exemplifications of Charity, Unity and Fraternity, and now it is our responsibility. There are many Councils and Districts performing in-person Exemplifications today following safe protocols of social distancing and utilizing face masks. I encourage every Council and District to form Exemplification Teams to provide in-person or virtual local Exemplifications. Providing a personal and local Exemplification for our newest Brothers creates a very memorable and meaningful experience for them. In addition to your local Exemplification Teams, there will be 5 Regional Teams across the State providing virtual Exemplifications. The Regional Exemplification Schedule will be published on our State website, [mikofc.org](http://mikofc.org). If you have a need for an on-demand Exemplification, go to [kofc.org/officers](http://kofc.org/officers) online for the on-demand Exemplification Invitation. With all these options, there should be no delays in bringing new Knights into our Councils.

Incentives for membership growth during the second quarter will be pumped up with an additional gift for your Chaplain. The highest growth percentage achieved within Large Councils (>201), Medium Councils (101-200) and Small Councils (<100) will receive a Chasuble & Stole Set for their Chaplain. In addition to this award, those Councils will receive dinner and a visit from our State Deputy at their month membership meeting.

I hope you are all very excited that Fr. McGivney will be beatified on October 31<sup>st</sup>. It is amazing to me that our Founder is well on his path to Sainthood. We should be proud to be Knights and part of Fr. McGivney's legacy. Please use this in your conversations with potential Knights and shares Fr. McGivney's vision that every catholic gentleman should be given the opportunity to be a Knight of Columbus.

We are on our way to fall in Michigan. Summer is leaving us, and the first quarter of the Fraternal year is over. Are your councils working hard on instituting Faith in Action Programs? In the Michigan Columbian you will find articles from each of the Four State Directors in Faith, Community, Life and Family. These directors are working hard on getting information to the councils in support of these programs.

Supreme has supplied us with all the tools and resources to institute these programs. While we are given detailed instructions on how to institute these programs there is some room in the execution of these programs. With a few exceptions we do not need to follow all the steps by the letter unless notated. Please reach out to the Supreme website at [www.kofc.org](http://www.kofc.org) and click on the Magic Red Button that says FOR MEMBERS in the upper right-hand corner of the screen. This is jumping point to all you need to access. This is not a protected area; it is there to help you find what you need to aide you in your duties at the council.

Here are a few examples of what our Knight's are doing To Rise Up and Answer the Call for Programs in this time of pandemic. Saline Council #6674 organized two food drives to support Saline Area Social Service clients. They also recently held a car wash for several beneficiaries. Council 13950 St. Mary of the Hills in Rochester Hills hosted a drive-in Eucharist Adoration, a phone campaign to call each Knight to see if they needed any help and the Knights were cooking meals to go to shelters to feed the hungry. Council #3042 Leo XIII Knights picked up food from a distribution location in Dearborn. Food that was then delivered and distributed from St. Veronica's food pantry. This allowed the food pantry to stay open at a time when replenishing supplies through normal means was disrupted. My home Council St. Therese of Lisieux 11957 in Sterling Heights has worked the parish grounds trimming shrubs, laying mulch, taking trees out, and repairing Msgr. Kasza's home. With the parish budget being tight, helping the parish save on expenses was a big help! Msgr Kasza was very grateful for our assistance.

At our most recent Archbishop's Gala on June 26th, which was virtual this year, the Knights presented a check to the seminary for \$150,000. That check is another step toward fulfilling the pledge of \$1,000,000 for the Seminarian Scholarship Endowment Fund. The Michigan Knights should be deeply proud of this year's effort, but not only that, the many preceding years and the years to come. This is an effort of the whole State of Michigan, and so it's a real 'team effort'.

**“SEPTEMBER WAS LIFE INSURANCE AWARENESS MONTH”****Raising Awareness about Life Insurance**

September was Life Insurance Awareness Month. McGivney] was deeply interested in pursuing the topic of a Catholic fraternal insurance society among groups of Catholic laymen of New Haven." Then on page 35 Mr. Kauffman goes on, "...he [Fr. McGivney again] spent his energy in promoting the insurance feature...his emphasis on business was his pastoral concern for the social and financial security of the family."

Fr. McGivney lived both the social and the financial insecurity of a desperate family, with the breadwinner suddenly taken, that had to be supported. He left the seminary to work and support his mother and siblings. He didn't want other Catholic families to find themselves in such a predicament. That, and uniting men of faith, was the impetus for establishing our Order. Everyone who joined in those first years was insured; that was part and parcel of being in the organization. Now every member has a choice and every member should know

what we do, and how we do it. Here's the process I use when I meet with families:

- 1. Discover – Identify & prioritize your financial goals**
- 2. Gather Data – Collect facts & figures based on your current situation**
- 3. Analyze – Input data, run calculations, identify shortfalls**
- 4. Recommend – Propose a financial strategy designed to satisfy your goals**
- 5. Implement – Choose a financial strategy and implement**
- 6. Periodic Review – Review regularly, measure success, make adjustments**

As you can tell, this is a painless process. But it can help any family, at any age, determine if they have blind spots in their coverage. It can help you avoid the pain of being underinsured. With a variety of life insurance products we offer we can help just about any person within any budget.

## St. Louis Center Reaches Out for Help in Age of COVID19

When St. Louis Guanella (1842-1915), the Founder of the Servants of Charity, reached out to his friends in the community to help him through the tough times he faced in trying to care for his “Good Children,” he always relied on Divine Providence and would say, “God will provide.” Soon out of nowhere, someone would knock at the door at just the right time when things were at their darkest to offer Fr. Guanella a charitable donation to get him through his next crisis. And God DID provide.

Today, as a result of the COVID19 pandemic, St. Louis Center has had a challenging year financially, with every planned fundraiser during the first half of the year cancelled or postponed, and the first fundraiser not taking place until Saturday July 18, 2020 as a “Virtual” Memorial Golf Outing. While we were successful at raising \$18,000 during this event, what we can’t replace is the loss of revenue from the absence of this year’s Palm Sunday MI Drives throughout the State of Michigan by the Michigan Knights of Columbus. Typically, there are 75-80 local councils throughout the year that contribute to St. Louis Center in support of the residents who are intellectually and developmentally disabled, but this year’s support has slowed to a trickle as a result of most of the Palm Sunday MI Drives having been cancelled.

And now we pray that “God will provide,” and that many councils will pick up the torch this fall on Columbus Day weekend for an MI Drive to help St. Louis Center and many other deserving non-profit organizations in need. This is of course, dependent on whether or not

a drive can even take place this fall if the pandemic is still hanging over our heads.

Many thanks to State Deputy Walter Winkle and the State Council for participating as a Gold Sponsor during our Golf and Glory Outing at UM Golf Course on Monday September 14<sup>th</sup>. Combined with this event, St. Louis Center will also be producing a “virtual” fundraiser for our 60<sup>th</sup> Anniversary on Thursday October 22, 2020 featuring former University of Michigan Basketball Coach John Beilein as a special guest, and there will also be a “virtual” Fall Auction on Saturday November 7, 2020 featuring a one week stay at a home in Italy as the top item. Finally, good news was reported in the last issue of the *MI Columbian*, as we talked about the five new buildings opening up in St. Louis Guanella Village this fall; including two adult homes, one residential home, one two-family duplex, and an administration building. Once we obtain occupancy permits, we should be able to move our folks in.

St. Louis Center is a residential care facility for 70 children and adults with intellectual and developmental disabilities in Chelsea, MI and is celebrating its 60<sup>th</sup> Anniversary this year. ## WHO IS HOLY CROSS SERVICES OF MICHIGAN?

### HOLY CROSS WOULD NOT BE WHO, OR WHERE WE ARE, WITHOUT THE KNIGHTS OF COLUMBUS!

Holy Cross Services has had a long-standing relationship with the Michigan Knights of Columbus as the Knights were part of our very foundation when the agency was formed in 1948 under our original name, Boysville of Michigan. It was Edward Cardinal Mooney's vision to create a place for boys (hence the name Boysville) to develop self-esteem and self-reliance, learn academics and develop spiritual values. These goals remain in place today at Holy Cross.

His determination and diligence were key factors in making Boysville of Michigan a reality. Cardinal Mooney invited the other four Michigan bishops and the Michigan Knights of Columbus to join him in his quest to care for young men who were experiencing family challenges, identified by local pastors.

In 1947, Ed Barrett, State Deputy for the Michigan Knights of Columbus, asked the delegates at their state convention to consider accepting Cardinal Mooney's invitation to make Boysville their principle charitable responsibility. This request was compatible with the mission of your founder, Fr. Michael J. McGivney- to care for widows and orphans. A unanimous decision was reached and the road to Boysville was soon to be paved, lives were restarted and hope instilled!

Eventually, Boysville extended its services to help girls in need as well and in turn, the agency name changed. In 1981, Edmund Cardinal Szoka had been appointed by the Pope to assume responsibility as Chairman of the Boysville Trustees. During Cardinal Szoka's term, Bishop Kenneth Untener of the Diocese of Saginaw asked for Boysville to assume administrative responsibilities for St. Vincent Home, which became the agency's first official center for young women.

We are eternally grateful for our continued partnership we have with the Knights of Columbus and all its members. Just as the Knights' Mission focuses on helping young people, families, and communities in service to the Catholic Church, since the day Holy Cross opened and true to this day, our Mission continues to and will always emulate Catholic values. That is also reflected in our core oversight, as we are also proud to say that the Knights of Columbus (as well as the Brothers of Holy Cross) have always had seats on our Board of Directors and the majority membership of our Board will always be comprised of persons of the Catholic faith.

Truly, our services are very in line with your Mission. Holy Cross Services helps the less fortunate, the most traumatized across Michigan.... abused, neglected, and abandoned children; homeless adults, children, and veterans; plus, youth and adults who suffer from addiction and mental health issues.

From day one, Holy Cross has served disadvantaged children and that will always be the heart and soul that drives us to serve communities all across our state.

One thing Holy Cross is very good at, is filling gaps in missing services to those in serious need. Over the years, we have been presented with opportunities to help even more hurting people. We added addiction and mental health services, since we know that many of the children we take in and care for, come from broken homes with these disorders. Our goal is to make every child better and healthy, to help get them on their best path for their best life. We look to treat the whole family, the whole situation. We also acquired a Lansing facility that provides comprehensive homeless services and shelter that serves over 6,000 homeless veterans, adults, and children every year.

It is our mission, it is at our core, to bring hope, promote change, and help ALL people live free, healthy, and productive lives.

We are so grateful that you have been with us, and continue to support us every day, along this journey! We cannot emphasize enough how valued the Knights are to our Agency, you have helped change, for the better, hundreds of thousands of lives over the years.

## Our Lady of the Woods Shrine



Our Lady of the Woods Shrine in Mid. Michigan

Built as a symbol of their faith; restored as a symbol of ours: The Our Lady of the Woods Shrine (The Shrine) celebrates its 65th anniversary in 2020.

The Shrine came as a dream-like vision to Father Rakowski while he prayed for guidance as the newly appointed pastor of the St. Mary Congregation of Mio. In July of 1953 with permission of Bishop Stephen Woznicki and two borrowed shovels but not a penny to spend, the faith-filled community of Oscoda County, Michigan broke ground on the shrine. Using stone donated by Onaway Stone Quarry, most of the work was done by hand with the help of a huge scaffold, a homemade elevator, shovels and wheelbarrows. Catholics and non-Catholics worked together to erect this mountainous limestone structure honeycombed with grottoes and niches to explore. Resting on footings that are 8 feet deep and 4 feet wide, it is estimated that 25,000 tons of native Onaway stone and an equal amount of cement were used to construct the Shrine.

On Sunday, September 4, 1955, more than 2 years after construction



had begun, Bishop Stephen Woznicki officiated the dedication ceremony. The ceremony was attended by 30 members of the clergy and over 4,000 people, both Catholic and non-Catholic. It is estimated that more than 20,000 people visited The Shrine that day.

Natural beauty of northern Michigan surrounds this Marian Shrine which has 32 Carrara marble statues and is filled with spiritual and natural symbolism. A statue of Christ the King welcomes you. Five Marian apparitions are depicted around The Shrine:

Lourdes, Fatima, La Salette, Mt. Carmel, and Guadalupe, as well as, the Assumption of Mary. The front grotto contains a beautiful Pieta statue. The grotto in the back honors the Holy Family and contains first class relics of St. Francis of Assisi, St. Anthony of Padua, and St. Anne. A third grotto on the south side has a mosaic of Our Lady of Czestochowa. Three niches and a water feature on the front contain elements representing God's magnificent creation of and blessings on the state of Michigan. Words can not describe the spiritual peace and splendor one experiences while visiting the Our Lady of the Woods Shrine.

In recent years, the Our Lady of the Woods Shrine has been undergoing restoration so that the Shrine will be retained for future generations. The first phases involved restoration of some statues, as well as, roof water-proofing and the removal and replacement of damaged stone on the back side of the Shrine. With restoration of the back of the Shrine complete, the next phases will include restoring the top and front portions, eventually moving to the store walk approach in the front, as funds become available.

Events planned for 2020 to celebrate the 65th anniversary of the dedication of the Our Lady of the Woods Shrine will be rescheduled in 2021. Plans to continue outdoor lawn-chair Masses at 6:00 pm followed by socials are set for the first Saturday of June, July, August, and September 2021 pending allowance under social distancing guidelines. Labor Day weekend will begin with the 66th anniversary dinner on Friday, September 3rd. Saturday, September 4th, is the last outdoor lawn chair Mass at the Shrine and social of the year, and Sunday, September 5th, is the Seven Sorrows of Mary Chaplet before Mass.

Knights Send Aid in Aftermath of Beirut Explosion  
 Stability in Lebanon seen as key to religious pluralism in Middle East



The Knights of Columbus has sent \$250,000 for disaster relief to Lebanon in the wake of the devastating Beirut explosion.

"This is a great tragedy that merits the prayers and full attention of the world," said Supreme Knight Carl Anderson. "The calamity in Lebanon is

a threat to the vital Christian community there and threatens the

existence of Christianity throughout the Middle East. This desperate situation must be addressed."

The Knights' gift was conveyed through Bishop Gregory Mansour, who leads the Maronite Eparchy (diocese) of St. Maron of Brooklyn, NY. It will include: \$125,000 for Caritas Lebanon; \$50,000 to the St. Vincent de Paul Society; \$50,000 for Telelumiere/Noursat Christian Television in the Middle East; and \$25,000 for Sesobel, which serves special needs children and their families.

Along with providing donations, Knights are often the first and last on the ground after disaster strikes. Louisiana Knights began recovery efforts immediately by assessing damage, determining pressing needs and identifying staging areas to receive critical supplies. The Knights

of Columbus Supreme Council is procuring and shipping requested supplies, including gift cards, tools, roofing nails, tarps, bottled water, ready-made food and cleaning supplies.

Offers to assist are pouring in from Knights of Columbus members in other states and countries. Supreme Knight Anderson said this is a typical reaction from fellow Knights. "It is fraternal charity and fraternal unity that distinguished the Knights of Columbus from other relief organizations. We stand shoulder to shoulder, supporting one another in faith and service across the world."

Bishop Glen John Provost of the Diocese of Lake Charles thanked the Knights for the assistance. He said, "We deeply appreciate the generosity of the Knights because the devastation in Lake Charles is enormous. The task ahead for us is most challenging but we know as in the past the Knights have always been there for us. God bless them!"

Last year, Knights of Columbus Charities Inc. and Knights of Columbus Canada Charities Inc. gave more than \$1.3 million to disaster relief with an additional \$3.5 million donated by local Knights councils and assemblies.

### Brother Knights

Please take a few moments to read and reflect on the words of Fr. Frank Pavone, National Director, Priests for Life - in an Open Letter to the Pastors of the United States.

It is a powerful letter and a clear call for Pastors across America to step 'Into the Breach' to defend Religious liberties which have been trampled upon for years.

We as Knights of Columbus are called also to step "Into the Breach" and be men of action, defending our families, our communities and our nation against the evil one and all his false promises.

Dear Pastors,

I write to you as a fellow preacher of the Gospel of Jesus Christ. This Gospel makes clear moral demands on individuals and on governments alike. The duty of preaching the Gospel involves not only the urgent exhortation to personal holiness and salvation, but the equally urgent exhortation to govern justly. Those responsible for the common good are obliged to protect the fundamental rights of the citizens and their freedom to live out their Faith in the way that they – and not the government – see fit.

Anyone who has been paying attention over the last six decades has seen an organized and persistent effort to limit the Gospel to the private arena of our hearts and within the four walls of our Churches.

Prayer and Bible reading have been banished from our schools. People of faith have had to fight in court to display religious symbols in public and to conduct their businesses and ministries in accordance with their moral convictions. The right to even talk about our faith has been attacked on campuses and in the media.

And as the courts have increasingly upheld religious freedom, haters of religion have now taken to the streets to show their contempt for our beliefs by destroying its symbols.

Moreover, the legal protection afforded to our most fundamental good, life itself, and to God's creation of marriage and the family, has been obliterated by amoral legislators and activist judges. Some 62 million children have been killed in the name of "freedom."

Yet our Founding Fathers, anticipating the extent to which human nature can fall into error and sin, have provided for us a system of self-governance that can overcome and correct even these drastic departures from the laws of nature and of nature's God.

Our nation is preparing to engage in two months of voting from September 4<sup>th</sup>, when the first absentee balloting begins, through Election Day, November 3. In this time, some 100,000 electoral races will be decided at every level of state and federal government.

We therefore have a choice.

And the choice we have is as relevant to what kind of church we will be as it is to what kind of nation we will be.

On the one hand, we can adopt a mentality that says that we have neither the duty nor the possibility of changing the course of public policy in our nation. This mindset takes various forms and utilizes various excuses.

Some maintain we cannot really know the difference between what's good for the nation and what isn't, or that morality is up to each church or individual to decide.

Some maintain that churches and pastors are to stay far away from any engagement in politics or public policy, and simply preach a Gospel that pertains only to individual, interior spiritual life.

On the other hand, we have the choice to engage the battle, taking on the same mindset that led pastors to preach the large body of political sermons of our nation's Founding Era, giving spiritual and moral energy and guidance to the very creation of our country.

We can commit ourselves to the same spiritual imperative that led believers to fight slavery and that led their descendants to move from the Churches into the streets to battle segregation.

We can be convinced of the words Rev. Dr. Martin Luther King Jr. preached on the night before he was assassinated:

"I'm always happy to see a relevant ministry. It's alright to talk about 'long white robes over yonder,' in all of its symbolism. But ultimately people want some suits and dresses and shoes to wear down here. It's alright to talk about 'streets flowing with milk and honey,' but God has commanded us to be concerned about the slums down here, and his children who can't eat three square meals a day. It's alright to talk about the new Jerusalem, but one day, God's preacher must talk about the new New York, the new Atlanta, the new Philadelphia, the new Los Angeles, the new Memphis, Tennessee. This is what we have to do."

We can understand that equipping the People of God to elect the right candidates is not a political task but a pastoral task, because we are enabling them to carry out the Great Commission, teaching all nations to carry out everything our Lord has commanded.

This is our choice, as we enter Elections 2020.

Our Lord told us we need to be attentive to the signs of the times. The problem is not that the Church is becoming too political, but that our politics have become too pagan.

The political divide in our nation is no longer between two major parties that "have the same goals but different ideas of how to get there." That was once true, but is no longer.

They have **different** goals, different views of America, totally divergent views of morality, and completely incompatible views of religion and the Church.

The Democrat Party platform has not only departed from the Republican Party platform in matters of policy. The differences are matters of **principle**. The Democrat Party platform has abandoned the principle of the God-given right to life and the liberty our Founders embraced to practice their Faith in their public life. Moreover, they have made their intentions clear to write into the laws and into the Courts a worldview completely devoid of those principles.

This is not the kind of divide we can "rise above," nor the kind of battle from which we can exempt ourselves or our congregations.

This is a test for us. Either we recognize this problem, and like good shepherds, warn our people, or we retreat into a 'neutrality' so absolute that it no longer allows us to see, much less neutralize, threats to the very survival of our nation and our ministries.

When a political party embraces the destruction of innocent life and the suppression of the freedom of the Church, it can no longer be treated in a neutral way by the Church. That Party becomes an existential threat to the nation to which we pledge our allegiance and to the Kingdom to which we have pledged our souls.

We are, moreover, at a moment when our President, Donald Trump, his Administration, and the Republican Party at every level, have achieved record-breaking accomplishments to protect our religious freedom from oppressive mandates at home and persecution abroad. The President has defended our freedom to preach in the pulpits, and the freedom of our children to pray in school and speak up on their campus for the Gospel of Jesus Christ. The over 200 federal judges he has put in place, moreover, are men and women likewise committed to religious freedom.

Dear pastors, at the founding of our nation, Pastor **John Peter Gabriel Muhlenberg** declared in his sermon on January 21, 1776,

"In the language of the Holy Writ, there is a time for all things. There is a time to preach and a time to fight. And now is the time to fight." He then threw off his clerical robes to reveal the uniform of an officer in the Continental Army. As one account relates, "Drums began to roll, men kissed their wives, and they walked down the aisle to enlist. The next day, **Pastor Muhlenberg** led 300 men of his church and surrounding churches to join General Washington's Continental Army."

Nearly two centuries later, Catholic Bishop **Clemens von Galen** (d. 1946), preached fearlessly against the Nazi regime and its oppression of human life and religious freedom. He was not afraid to name and fight the political threat that was right before his eyes. It is not that these men abandoned their pastoral mission in order to become political. It is, rather, that they saw the demands that their pastoral mission placed on them in the circumstances of their time, and courageously rose to the occasion.

That is the choice, and the opportunity, you and I have before us right now.

The choice for our nation is not simply about which political party will have power, but about which kind of America we will be – one marked by moral chaos, the Culture of Death, socialism and religious oppression, or one based on the freedom and principles our Founders made clear.

And the choice for our churches is whether we will retreat in silence and cowardice out of fear of being 'too political,' and hence become irrelevant to the world around us, or respond clearly and courageously to this moment of unprecedented conflict, and lead the People of God to protect their rights, their freedom, their Church and their beloved country.

**Knights Send Aid in Aftermath of Beirut Explosion**  
Stability in Lebanon seen as key to religious pluralism in Middle East

Bishop Mansour said the donations "mark the special charism of the Knights: to serve the poor, to lift up our special needs children, to communicate the saving message of Christ, and to remind the small and tireless Church now in Lebanon... that men of good will are near to them in their time of need."

The Knights' gift follows a donation by Pope Francis of 250,000 euros (\$295,488) in aid as an expression "of his fatherly closeness to people in serious difficulty," a Vatican press release stated.

At least 178 people were killed and 6,000 were injured in a blast near Beirut's port on Aug. 4. The explosion caused extensive damage to the city and flattened buildings near the port. Some 300,000 people were left temporarily homeless.

Since 2014, the Knights of Columbus has spent more than \$25 million on behalf of persecuted Christians and other religious minorities targeted for elimination in the Middle East. The support has funded rebuilding – and saving – the town of Karamles, Iraq, after its liberation from ISIS; fed tens of thousands of displaced people; provided short-term and long-term housing for the displaced; and supported educational, medical and other programs for those targeted by ISIS.
