Individually, you don't have to become a major donor, or full-time volunteer, or a super-recruiter. But, if every member, or every council could do just a bit more, it could have a staggering increase on the impact our order can have here in Michigan. If you are a silent, non-participating member; attend just one council function this year. If you are already involved; can you participate in one more fundraiser over the course of the year? When donating time; sign up for two shifts instead of one. When donating funds to charity; dig just a little deeper and make a bigger contribution this year. Someone who needs it, will benefit from your generosity. If you recruited a new Knight last year; make it **two** this year! If you haven't recruited anyone in a while, or ever... do it **now**. Every catholic man should receive a personal invitation to belong to this great order. And just think about how much you contribute to our good works by bringing that new Knight in! Everything they contribute is a result of your effort, your invitation. One more ultrasound machine, saves dozens of lives a month. An extra case of coats keeps even more kids warm in the winter. A food packing event hosted by your district will provide thousands of meals for the hungry. A few more dollars toward seminarian education may be the difference for a young man to answer his calling to become a priest, or a young lady to take her vows.

"A" is for Aspire. I have challenged all the state leadership to aspire to do more, to do better, to be more effective at fulfilling Blessed Fr. McGivney's vision of providing a faith-based fraternity for catholic men to help each other and our families grow in our faith, serve and protect others in need, support our clergy and religious, and lead more people into (or back to) the Church, Holy Mass and the Eucharist. We can do this by each of us contributing just a little bit more.

There are many men across this state who volunteer their time and talent to provide leadership at the council, district, diocesan and state levels. We are blessed to have some very capable, dedicated, professional people who mentor, guide, teach, train, provide oversight and leadership, and help execute programs. These men of action deserve your admiration, respect and gratitude. Please know that many of these men sacrifice personal time, family functions, even career opportunities to give of themselves for the order. But, for most of them, it is a labor of love. Whether it's the confident encouragement behind the scenes or it's elbow to elbow working on a project, our ladies and kids are an important part of this fraternity too. Thank you.

I hope many of you have noticed the increased attention placed on Evangelization and Faith Formation. Even just a few years ago, we focused our attention on the two pillars of Membership and Programs. Now, under the leadership of Supreme Knight Patrick Kelly, we are more intentionally looking inward at our catholic identity and encouraging councils to implement faith-based activity. While some still exist, the hall-based council model is much less common than in the past. Even where there is a hall, councils are encouraged to think and act with a parish-centered mindset. Our activities that include prayer, formation and fraternity have popped up in many different forms. There is great flexibility with these programs and you can be quite creative. Our bishops are firmly behind this effort to provide adult male faith formation through our councils' leadership. Participate if you can, or ask about starting something in your council.

Mandy and I look forward to seeing our leadership team at the upcoming Winter Leadership Conference and we continue to wish you and your family a "Year full of Hope." May you be blessed this upcoming Christmas season and continue to SOAR with us as we all try to give just a little bit more.

Only One Priority



Our pilgrim icon during this year is the Sacred Heart of Jesus. We know that our blessed founder had a great love for the Sacred Heart. Devotion to the Sacred Heart of Jesus is a beautiful devotion in the Church. The beloved Sacred Heart statues, icons, or stained-glass windows that we encounter remind us that Jesus' heart beats out of love for us. Your parish could do a Sacred Heart Holy Hour to help foster devotion to Jesus.

Do you make God a priority in your life? Think about that question. Answer it in your heart. Now I am going to tell you that you shouldn't.

In the Gospel of Luke, Jesus says, "I have come to set the earth on fire, and how I wish it were already blazing!" (Luke 12:49). He then goes on to say that he came not to establish peace but division. Jesus is the Prince of Peace, but here he says he came to bring division, division among family members no less? Don't daughter in laws and mother in laws have a hard enough time without Jesus saying he has come to bring division among them?

At our staff meeting before this Gospel was proclaimed, we were reflecting on the readings, and I was reminded of something Jeff Cavins said. He said that the word "priorities," the plural of priority, did not exist until the 20th century. There was only the word priority, which means first in rank, order or dignity. Only one thing can be first. Pluralizing priority implies that many things can be first, thereby making what is first no longer actually first.

The Gospel helps us to ask, "Is God the priority?" not "Is God a priority." I think we tend to think and live like this, "My family is a priority, my job is a priority, God and faith is a priority, etc." We can think that this is a good thing. That it is good to make God a priority. But it isn't actually. This is not a biblical way of looking at our life, and that is what Jesus is trying to tell us. He is not saying that he wants families to be torn apart. He loves family life. He is saying that God alone is the priority; God alone is first. When we live that way we may end up being a cause of division, not because we want division, but because we are putting God first.

"I have come to set the world on fire and how I wish it were already ablaze." The fire is the fire of Jesus' love, so symbolized by his Sacred Heart. It is the fire of passion. Love has a way of giving clarity to our lives. We cannot understand this passage apart from love. Love sometimes leads to division. Any parent who has ever had to say, "Take your medicine" or "It is bedtime" or "It's time to go to school," knows that sometimes division comes with love.

A few years back Pope Francis gave a homily reflecting on the Sacred Heart of Jesus. He said, "To remember [in Italian, *ricordare*], means 'to return to the heart, to return with the heart'. Ri-cordare. What does the Sacred Heart of Jesus make us return to? To what He did for us: the Heart of Christ shows us Jesus who offers Himself, it is the compendium of his mercy."

Jesus is saying with this Gospel "Return to my heart. Do not draw away from the fire of my love and lead a cold life of indifference and neglect." Making God the only priority reminds us that we are made for relationship, intimacy, friendship and union with God. Is the Sunday Mass put first in the schedule of my week? Is daily prayer part of my life? Do I receive confession regularly? Do I embrace the teachings of the Church, including the hard teachings, and strive to live by them even as I fall short, ever mindful of the great mercy of Jesus?

This Gospel is also an appeal to our hearts. It is as if Jesus asks, "Where is your fire?" Is it dissipated and therefore going to fizzle, or is it centered on the only priority? This Gospel challenges us all, myself included. Challenges us to go to the heart of Jesus and to go with our heart.

Jesus' words are the words of love. Love always brings comfort to us while at the same time calling us to ascend to the heights. How can I order my life in such a way that God is the one priority?

Many thanks for all you do to build up the Church! May Jesus fill us with his fire! Blessed Michael McGivney, pray for us!

My Worthy Brothers, Ladies and Michigan Knights of Columbus family,

I hope you are all well and fully engaged in our mission of empowering Catholic men to more fully live out their faith at home, in their parish, at work and in their community. Being a Knight of Columbus is the best way for a Catholic man to experience the richness of our faith. As the State Advocate, it is my responsibility to help our Brother Knights and their Councils utilize the Constitution's Laws and Rules of our Order in the planning and execution of council business. Successful councils make it a habit to plan, communicate and practice successful techniques in the achievement of their fraternal goals. Every council should have started this fraternal year with the goal of achieving Star Council.

Here are some communication best practices that will help your council plan and achieve your fraternal goals. Every council has four email accounts that should be used by the Grand Knight, Financial Secretary, Program Director and Membership Director. These emails also unlock another critical tool of communication, the State Leadership Directory. For many years now, email has been our primary tool of communication and contains the most updated information for every council district and diocese. Each week the Grand Knight should be forwarding the MIKOFCC Constant Contact newsletter to all their council members. On a monthly basis, councils receive leadership talking points that help in the planning of timely and important events. Another best practice utilized by many councils is emailing monthly meeting minutes to council members. This keeps ALL your members, not just the meeting attendees, up to speed with council successes.

What are the best ways to protect council finances, meeting integrity, and avoid scandal? First is to be fully compliant in youth protection. Next is to obtain liability insurance for your council. If your council does not have a liability insurance policy, a quote can be obtained by contacting Lockton Affinity at 1-800-496-0288. Having an annual budget for your council is a financial best practice. When you vote to approve the council's annual budget, many of the expenses that exceed \$500 will already have their initial approval. This allows for a more expedited approval process. Pre-planning is an effective financial tool. When writing checks, they should have the following elements: Always record on the memo line what the check is intended for and it should be signed by both the Financial Secretary and Grand Knight. Also, never give out cash to a charity or Brother Knight in need. Your council checking account, Trustees and Financial Secretary records must account for cash collected for charity. This protects all parties for any perceived fraud or temptation.

Finally, use our Constitution Laws and Rules, Roberts Rules of Order, and your Council Bylaws. Using these documents will guide your council in effective meeting execution and prevent questions of procedure and protocol. If you have any questions regarding these topics, please let me know how I can help.

My wife Kara and I wish you a blessed autumn season. We hope you enjoy a great Thanksgiving and Christmas and make sure to share the blessings of our Order with all the Catholic men in your parish, community and family.

From there, you can modify as needed or add any more details if needed.

Final submissions of the State Program Award will be March 27th, 2026. Remember you can submit an entry for each of the Faith in Action categories and are **NOT** limited to just one entry.

The Basilica was full to capacity and everyone in attendance was in awe of the beauty of the Cathedral, music, and considerable number of Color Corps in attendance.

Once again, everyone was proud to be from Michigan and the efforts put forth by our Knights. At the award ceremony, St. Mary of the Hills Council 13950 in Rochester Hills, MI was the recipient of the Life Programs Award for the Fr. McGivney Field of Dreams.

The Ladies Program did not disappoint anyone in attendance. Montse Alvarado, President and COO of EWTN News was the Emcee. The keynote speaker was Jeanne Mancini, a leadership coach and consultant specializing in support for nonprofit and faith-based leaders. She is a recognized voice on pro-life policy and frequently advises both religious and government leaders. Our Emblem is a Reflection of Life

We wear it on our sleeves, shirts, and jackets. We take pride as we wear it at council meetings, at Mass, and in the community. We place it on banners, flags, posters, council lecterns, podiums, and on promotional advertisements.

It is the emblem of the Order which contains the sword, the anchor, and the battle axe. Each symbol has a distinct meaning which we all have a responsibility to live up to. And this responsibility applies to the Life initiatives and programs we lead or take part in.

Let's look at these symbols on the Knights of Columbus emblem and how they provide opportunities to live up to our responsibility within our Life initiatives and programs.

The sword symbolizes honor, distinction, bravery, and courage.

Supporting Special Olympics can bring honor and distinction to many. This is exemplified by the International Program Award, Life Programs, awarded to St. Mary of the Hills Council #13950, Rochester Hills for their efforts to making a reality the Blessed Fr. Michael J. McGivney Field, an A.D.A. compliant baseball field.

Our actions to Defend Life demonstrate bravery and courage. Do so by participating in Fall pro-life events including the Living Rosary (September 13th at the State Capitol), 40 Days for Life Rally (September 24th through November 2nd), the Life Chain (Sunday, October 5th) at locations throughout the state, and the MI March for Life (Thursday, November 6th) at the State Capitol. These events, with our participation, will help our pro-life partners overcome the evil of abortion and continue our right of religious freedom.

The anchor is an instrument designed to hold a ship in place, symbolizing that which attaches, stops, and stabilizes.

The Ultrasound program, a marquee program of the Knights of Columbus, demonstrates how important attachment is. We just celebrated our 101st ultrasound placement in Michigan (lead by St. Mary of the Lake Council #14366, New Buffalo, Women's Care Center, Niles) to help stop abortion. And now, we are looking forward to the placement of six more units in Saginaw, Port Huron, Sturgis, Allegan, Holland, and Dearborn Heights.

The Silver Rose program demonstrates the stabilizing unity between Knights of Columbus in Canada, the United States, and Mexico. The Silver Rose is a message of Our Lady of Guadalupe that promotes respect for life by participating in a meaningful pilgrimage with a series of prayer services focusing on the dignity of all human life while honoring Our Lady.

With over 2,000 "Created in the Image of God" baby blankets distributed since its start has brought warmth and comfort to newborn babies. A special thank you to all the councils and members that have purchased these blankets and shared them with your parishes, hospitals and your family. The emblem of the Order proudly displayed on the baby blankets along with the inscription is a clear sign of our commitment to start stable family lives with love and hope.

The battle axe, placed on a shield, symbolizes action taken to overcome obstacles or ambushes on the road to accomplishing one's objectives.

A Mass for People with Special Needs aims to welcome those who may not feel comfortable participating in other Sunday Masses due to physical barriers, social barriers, or family anxiety.

The Aid & Support After Pregnancy (ASAP) program provides a way for councils to help local Pregnancy Resource Centers and Maternity Homes overcome obstacles. Since the beginning of the ASAP program in 2022 through the end of the last fraternal year, MI Knights of Columbus with matching funds from the Supreme Council have donated \$1.2 million to Pregnancy Resource Centers throughout the state.

Our new goal, ASAP100, challenges us to reach 100% of active council participation during this fraternal year. You are critical in helping us accomplish this objective.

Brothers and Sisters,

What happens when you ride as a Disciple of Christ, spreading the Love and Truth of our Lord? What happens when you stand for your faith against a world that has turned their backs on Christ, is there hope for mankind?

Let me start with the last question first. As you know, I was in a battle with my employer over their DEI policy, which attacked my religious freedom. By the Grace of God the company was defeated and policy removed. I continued talking to other employees on how to stand up and fight with the result of more standing for their Faith. I felt that I had accomplished what God wanted me to do and it was time to retire and move on. I requested to have an exit interview instead of just filling out a form. The interview was granted but I could only have a half hour. When I went for the interview, the HR rep that I fought the battle over the DEI policy was the one to give my exit interview, she was very welcoming and stated that she requested to give me the exit interview. She started out asking why I was retiring before the age of 65 and I told her that this has been the most unethical and immoral company I had ever worked for and they go above and beyond promoting the use of birth control and LGBTQ agendas. She agreed and typed everything I had told her. We talked about faith, future plans and finally got to the **forcing of people to sign policies that went against their faith**. She looked at me and said this is why I wanted to give you the exit interview. She went on to explain that when we battled over the DEI policy, she took a copy of the scripture readings from the New and Old testament and went home. She said that she and her husband sat down and read them in the Bible. They were amazed at what they had read and did not realize how far people had fallen away from GOD. She said because of that fight and then reading the Scripture, she wanted me to know that she and her husband are now going back to church. God reclaims two more souls!

On our ride to the Knights on Bikes International Rally in St Augustine, Florida we made our way into the mountains of Kentucky.

What wonders of God we experienced, twisty roads, beautiful waterfalls and Brotherhood. It was time to come out of the mountains and make up some time riding the highway. Little did we know, this is where everything would change. We were now on flat roads and my bike would go nowhere. A Canadian riding behind me yelled to pull over. I got off my bike to find my drive belt stretched out on the road behind me, not good! No dealer in Kentucky had a drive belt for my bike. My HOG membership was able to get a tow truck, but he was 200 miles from me in Tennessee. He called me and I explained the situation and asked if he would be willing to tow it to Tennessee where there was a belt. He said that would be a big bill on top of what the Insurance paid. He gets \$9 a mile and I had no choice. He brought his wife and son because the distance was so far. We loaded up the bike, I rode in the truck with him and his family and we all headed to Tennessee. He had bought pizza and broke bread. He said normally he would not do this, but after talking to me on the phone, he knew I was a man of God and wanted to help. His wife gave her testimony, He gave his testimony and I gave mine. He wondered why the rest of the bikes were following

him, the answer was we are all Brothers and will not leave anyone behind, He thought that was pretty cool and wanted to know more about Knights on Bikes and the Catholic Church. We finally arrived and he offered me a place to stay but I had to be in Florida. He told me not to worry about the tow, what the Insurance paid was good enough and we said a final prayer before he left.

We spread my luggage across the rest of the Bikes, I climbed on the back of my wife's bike and we headed to Florida. Now, I had never rode on the back of a bike. This gave me time to think, if I had been in the mountains and this happened, it could have turned out very bad. Did God and our Holy Mother protect me? Did God need me to talk and listen to this family and I needed to be humbled? I believe the answer is and was YES! After getting to Florida, Brothers wanted to take me to a dealership to rent a bike instead of riding on the back. I told them that God had protected me from harm and needed to humble me, so I will not interfere with his plan, not knowing what he had in store for me next! What a wild ride to abandon yourself to God's will.

We had gone on several rides to shrines and beautiful scenery. My wife said that she needed to get gas. She pulled into the gas station and I had an overwhelming feeling that I was there for a reason. I asked Loree if she could fill the bike while I walked over into the shade and had a smoke? As I was standing there, I could feel someone standing behind me. I slowly turned around to find a man covered in tattoos from the ears down with muscle on top of muscle. This man claimed that he has been watching us for a few days and wanted to know where we were from. I said to him, Brother, we are world wide, we are Knights of Columbus members called Knights on Bikes. We are here in Florida for a Rally and we evangelize by riding and spreading the Truth and Love of Jesus Christ.

The man then introduced himself as a Hell's Angel out of Fresno, California. He then proceeded to tell me that he thinks what we are doing was very cool, he has spent 22 years in prison for the club. The whole time he was in, his wife was repeatedly raped and his children beaten and abused. He stated that is not what a brotherhood is supposed to be. Watching us, he wished he would have had that. He said he appreciated that I was willing to talk and listen. I told him God put us together for a reason. He said he is leaving the club and hopes to find what we have. Then he said he can't leave California because his mother has stage 4 cancer with not much longer to live, when she passes he will take his family and flee. He then asked if I would pray with him? My answer was Absolutely my Brother! We prayed, shed a tear. He then said he has never asked for this from a man before but, can I have a hug? Tears and a hug in a Buckee's gas station from a man representing God and the other a Hells Angel.

These things would not be possible without surrendering yourself to the Will of God. Everything we do should be directed to one thing, The Salvation of Souls. Learn your Faith, use COR and be a man of GOD.

I am pleased to make this annual report of the “TEN FOR CHARITIES” program for the 2024-2025 fraternal year. This was a *successful* year of Active Charity. Council contributions amounted to a grand total of **\$122,672.56**. This generous giving is due to members responding to the call of charity by the message on the Take 10 For Charity slips sent with their dues notices, then acting on that call by sending in their donations to their councils, and with your Financial Secretaries forwarding these donations to the State Secretary. Brother Knights and Ladies, working together you are participants in this program which allows our State Office to make contributions to worthwhile charities in amounts that are generally too large for our individual councils to make themselves. I and the State Officers thank you for exercising our Order’s First Principle of Charity.

While this is a sizable amount, the cold reality is that it is still much less than our maximum potential. We were able to reach this amount with donations from 192 councils. Sterling Heights, Michigan – For the past eight years the St. Nicholas Council #7011 has conducted our popular annual Baby Bottle Campaign in support of Knights of Columbus' National Right to Life initiatives, hosted by our supporting parish, St. Cyril & Methodius Slovak Catholic Church.

St. Nicholas Council raised a record amount of \$13,500 in 2025, which brings the total donations from our parishioners to \$80,000 over these past eight years. In addition, we previously received \$5,000 from another pro-life fund and \$16,000 matching funds from the Supreme Council, which resulted in \$101,000 support to Mary's Mantle and other pro-life pregnancy centers over these past eight years. These funds go toward facility improvements, operating costs, expansions, and new equipment.

From Mary's Mantle's mission statement: "Mary's Mantle is a Catholic residential program for homeless expectant women. We witness the love of Christ by promoting the dignity of life. We provide a safe, faith-based, and caring environment that supports the transition into motherhood, including extended aftercare for continued personal growth and integration into the community. We focus on the spiritual, emotional, physical, educational, and vocational well-being of mother and child."

"These lifesaving donations could never have been achieved without the generous love and support of the parishioners of St. Cyril & Methodius parish. When the need is greatest, as it is now, we can always count on our neighbors and friends at St. Cyril's to open their hearts and wallets and help us help others," said Gino Vitale, St. Nicholas Council's Right to Life Chair.





Now preparing to graduate high school, Lee is building a future rooted in purpose. “You’re your biggest self-advocate,” Lee says. “Even at rock bottom, you can rise.”

Adopt A Highway 2025 Summer Cleanup

Here's 6 Recent Victories for Pro-Life Americans

1. Americans' Growing Discomfort with Abortion

Evidence suggests that a sizable number of Americans are uncomfortable with abortion. For example, a 2024 Pew Research article indicates that 36% of Americans believe abortion should be illegal in all or most cases—revealing that more than a third of the nation supports stronger restrictions.

2. Defunding Planned Parenthood on a Federal Level

As part of the anti-life culture, ever since 1970 when Title X was passed and signed into law, politicians have forced taxpayers to subsidize Planned Parenthood—the largest abortion provider in America. Immediately, Planned Parenthood not only received millions of taxpayer dollars in Title X funding to pay for abortions and birth control across America, but soon after also received millions more annually from taxpayer-funded USAID grants to promote "access" to abortion worldwide.

3. Defunding Planned Parenthood at the State Level

In June of this year, the U.S. Supreme Court handed down a landmark decision in Medina v. Planned Parenthood South Atlantic. The Court ruled that Medicaid beneficiaries do not have an individual right to sue if their state excludes Planned Parenthood from Medicaid networks—strengthening states' ability to defund and exclude abortion from tax-funded "healthcare." Yet another huge victory.

4. Major Setbacks for Planned Parenthood: Flagship Closures

In early April 2025, the Trump administration began to withhold tens of millions in Title X family planning funds from Planned Parenthood affiliates, claiming ideological misalignment.

Pro-abortion proponents like KFF and the Guttmacher Institute claimed that removing Planned Parenthood from federal funding streams would leave massive gaps in access to abortion and contraception, gaps that other health centers can't realistically fill.

5. More Major Setbacks: Forty-One Planned Parenthood Closures Nationwide

More than just flagship clinics, a remarkable shift is underway: 41 Planned Parenthood centers have closed as of August 2025—a powerful sign that America is moving toward greater respect for the life of the unborn. These closures, quietly enacted across various states, mark an important victory for those who have long advocated for the protection of unborn children.

6. Another Big Victory: Costco Won't Sell the Abortion Pill

In another encouraging development, national retailer Costco announced it will not sell mifepristone (the abortion pill) in any of its more than 500 pharmacies across the USA. The company cited low customer demand as its primary reason

Moving Forward

Pro-lifers have a lot to be thankful for in 2025. From the closure of abortion centers—especially high-profile ones like Prevention Park and Bleecker Street—to the growing support for defunding Planned Parenthood at multiple levels of government, and even pharmacies declining to fill abortion pill prescriptions, these developments represent real and meaningful strides forward for the pro-life movement.


